Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested alleged persons namely (i) Khagen Gope (40 Yrs) S/o- Srikanta Gope (ii) Joydeb Rajwar (42 Yrs) S/o- Lt. Bhagu Rajwar (iii) Sambhu Gope (37 Yrs) S/o- Rampada Gope all of of Vill+PO- Bagalmari, PS- Para, Dist- Purulia (iv) Selim Ansary (61 Yrs) S/o- Lt. Rahaman Ansary of Vill- Chalunia, PS- Para, Dist- Purulia (v) Bablu Roy (36 Yrs) S/o- Lt. Shyamal Roy & (vi) Subhash Roy (45 Yrs) S/o- Lt. Pahalan Roy both of of Vill- Laxmipur, PS- Chandankeyari, Dist- Bokaro, Jharkhand and 06 (Six) bicycles loaded with illegal coal in four plastic sacks containing approx 15 (Fifteen) quintal of coal and also taken sample of total 06 kgs coal 1 kg from each bicycle.

I beg to state that on 04.11.2023 at about 10.25 hrs I received source information from my source that some persons loaded with illegal coal by bicycles in plastic sacks are coming to Pirargoria village under Purulia (M) PS from Jharkhand side. After receiving the information I contacted you and as per guidance and instruction myself along with ASI Partha Sarathi Murmu, C/- 1350 Subodh Bauri, C/- 154 Rajib Nag, C/- 851 Amrit Banerjee & C/- 241 Sumit Chakraborty all of Purulia (M) PS, Dist- Purulia vide Purulia (M) C.C No- 5090/2023, Dtd. 04.11.2023 and GDE No- 215 Dtd. 04.11.2023 left that place to work out the information and to track and stop this illegal transportation of coal. Accordingly, myself along with force reached Pirargoria forest near a banyan tree under Purulia (M) PS at 11.35 hrs and managed to stop the above noted persons. On seeing the Police party the above noted alleged persons tried to flee away to leave their bicycles loaded with coal but we managed to apprehend them. On being asked the apprehended persons disclosed their identity as noted above. On demand they failed to produce any valid document in respect of loaded coal. On preliminary enquiry it could be learnt that the above noted persons along with others, from where the coal has been procured and selling the illegal coal from different places and transporting the same in a clandestine manner. So, it is reasonable to believe that they were transporting the coal illegally after procuring.

Accordingly I seized the above noted 06 (Six) bicycles loaded with coal approx 15 (Fifteen) quintal under proper seizure list duly signed by the accompanied Police persons as no local witness showed interest to be witness, as such I could not collect the signature of the local people in seizure list during seizure. I have taken total 06 Kgs of coal 1 kg from each bicycle as a sample after preparing the proper level. The seizure was made between 11.45 to 13.20 hrs. I also

arrested the above noted accused persons after maintaining all formalities regarding arrest. Informed them the ground of arrest and issued Memo of Arrest and after issuing check lists. After that we made a proper arrangement and brought the arrested accused persons and seized 06 bicycles loaded with coal at PS for custody.

Therefore, I pray before you that a specific case may kindly be registered against the alleged persons namely (i) Khagen Gope (40 Yrs) S/o- Srikanta Gope (ii) Joydeb Rajwar (42 Yrs) S/o- Lt. Bhagu Rajwar (iii) Sambhu Gope (37 Yrs) S/o- Rampada Gope all of of Vill+PO- Bagalmari, PS- Para, Dist- Purulia (iv) Selim Ansary (61 Yrs) S/o- Lt. Rahaman Ansary of Vill- Chalunia, PS- Para, Dist- Purulia (v) Bablu Roy (36 Yrs) S/o- Lt. Shyamal Roy & (vi) Subhash Roy (45 Yrs) S/o- Lt. Pahalan Roy both of Vill- Laxmipur, PS-Chandankeyari, Dist-Bokaro, Jharkhand under proper section of law.


