Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Binod Dubey (34 Yrs) S/o- Lt. Anil Dubey of Vill- Shibdih, PS- Purulia (M), Dist- Purulia and seized articles (i) 16 (Sixteen) sealed bottles of 'DIL KHUSH' & (ii) 08 (Eight) sealed bottles of 'Officer Choice' (FL) along with seizure list, Memo of Arrest.

I beg to state that today (09.11.2023) evening while I along with force (i) C/- 154 Rajib Nag (ii) C/- 06 Debdas Mukherjee all of Purulia (M) PS vide GDE No- 519 Dtd. 09.11.2023 were performing Night mobile duty. During my Night mobile duty, at about 20.45 hrs I received a secret tip off that an illegal possession of a huge quantity of liquors. Subsequently, I informed the matter to you and as per your direction, I rushed to the spot i.e Pandey Hotel situated at Aimundih X-ing on the side of Purulia-Ranchi Road (NH-32) under Purulia (M) PS and after arriving at the spot and as per your instruction conducted raid in the said Line Hotel at about 21.05 hrs. During the raid some people fled away and detained one person. On being asked he disclosed his identity as Binod Dubey (34 Yrs) S/o- Lt. Anil Dubey of Vill- Shibdih, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he stocks the liquors for selling illegally in his Hotel. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors from his Hotel. Subsequently, I seized (i) 16 (Sixteen) sealed bottles of 'DIL KHUSH' containing 600 ml each & (ii) 08 (Eight) sealed bottles of 'Officer Choice', containing 180 ml each. In which 02 sealed bottles were taken as samples from each item. I seized the same under proper seizure list in presence of witnesses, duly signed by the witnesses and accused person. The seizure was made between 21:15 to 21:35 hrs. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Accordingly, I arrested the involved accused person namely Binod Dubey (34 Yrs) S/o- Lt. Anil Dubey of Vill- Shibdih, PS- Purulia (M), Dist- Purulia at 21.45 hrs after maintaining all formalities regarding arrest and NHRC guidelines, issued Memo of Arrest. Informed him regarding the ground of arrest and also informed his family members.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Binod Dubey (34 Yrs) S/o- Lt. Anil Dubey of Vill- Shibdih, PS- Purulia (M), Dist- Purulia under proper section of Law.
