I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused has committed interference with meter or work of licensee U/S 138 I/b of the electricity Act 2003, Amendment of 2007 as stated here under.

Today i,e, on 10.11.2023 I, Sri Prashant Kishor DE & SM along with Sri Suraj Kumbhakar JE (GR-I) & Sri Deb dulal Banerjee Sr TSH of Telkalpara CCC,WBSEDCLwent to make an inspection to workout upon a source information regarding unauthorized reconnection of a service connection bearing consumer id no 242043657 in the name of Sanjay Mahali Village of Hatuara ,Dist-Purulia. The service connection was disconnected by WBSEDCL on 21.05.2018 due to non-payment of outstanding bill. The outstanding is Rs 8080.47 excluding applicable late payment surcharge as per regulation. The service connection is in deemed disconnected status in our database.

During the time of inspection at the domestic premises 1 nos of electricity meter was found having serial no BR643889 (Consumer id 242043657, Consumer Name- Sanjay Mahali. The meter was connected to the mains through a service cable. The user Sanjay Mahali was enjoying electricity service and the reading on the meter was recorded 5912 KWH.

In presence of the inspection team at about 02.48 P.M. entered to the premises and observed that user Sanjay Mahali was using electricity whimsically re-connecting the service line bearing consumer id no 242043657 and has made offence under section 138 (1)(b). Accused has made huge financial loss to WBSEDCL.

After detection of unauthorized reconnection of service line illegally and dishonestly, the inspection team disconnected the service line in the premises from pole with the help of LT Mobile Van Team.

The inspection team left the premises at about 03.05 P.M..

The accused Sanjay Mahali S/O Ambuj Mahali of Vill - Hatuara P.S.-Purulia(M) has committed interference with meter or work of licensee under section 138 (1)(b) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
