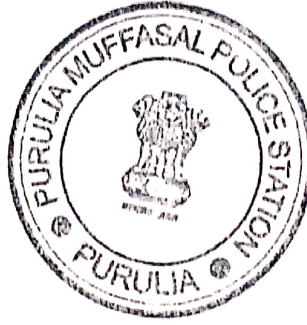

Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused persons namely (i) Ajim Majhi (25 Yrs) S/o- Lakhiram Majhi & (ii) Ambuj Majhi (32 Yrs) S/o- Rathu Majhi both of Vill- Shalga Dumdumi, PS- Arsha, Dist- Purulia and seized articles (i) 08 (Eight) Plastic containers, each contained with 05 (Five) Litters, total  $8 \times 5 = 40$  (Forty) litters illicit distilled liquor (ii) One M/C having Registration No- JH 10Y 9873 along with seizure lists and Arrest Memos.

I beg to state that on (11.11.2023) night while I along with force (i) C/- 988 Shyamal Kr. Rajwar (ii) C/- 2498 Ranjan Kr. Samanta both of Purulia (M) PS, Dist- Purulia vide Purulia (M) PS GDE No- 606 Dtd. 11.11.2023 are performing night mobile duty, at about 23.05 hrs I received a secret tip off that one M/C having Registration No- JH 10Y 9873 loaded with illegal liquors was coming from Garafusra village side towards Chas morh under Purulia (M) PS. Subsequently, I informed the matter to you and as per your direction, I rushed to the Chas morh X-ing under Purulia (M) PS and after arriving at the spot myself along with force started Naka checking at that place to work out the information. At about 23.25 hrs we found one motorcycle was coming towards Naka point, detaining the M/C, which was carrying one plastic container and one pillion rider. We stopped them and on searching, found 08 (Eight) Plastic containers each contained with 05 (Five) Litters, total  $8 \times 5 = 40$  (Forty) litters illicit distilled liquor. On being asked they disclosed their identity as (i) Ajim Majhi (25 Yrs) S/o- Lakhiram Majhi & (ii) Ambuj Majhi (32 Yrs) S/o- Rathu Majhi both of Vill- Shalga Dumdumi, PS- Arsha, Dist- Purulia. On being interrogated they confessed that they are carrying the illicit distilled liquors for selling illegally in their secrete places, so that they could gain more amounts from the selling illegal liquors. On demand they failed to produce any valid document in respect of carrying and possession of the said illicit liquors. Subsequently, I seized (i) 08 (Eight) Plastic containers, each contained with 05 (Five) Litters, total  $8 \times 5 = 40$  (Forty) litters illicit distilled liquor (ii) One M/C having Registration No- JH 10Y 9873 in which 01 litters of liquor was taken as samples from the said plastic container in a bottle under proper seizure list in presence of the witnesses, duly signed by the accused persons. The seizure was made on 11.11.2023 at 23.40 hrs to on 12.11.2023 at 00.05 hrs. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused persons.

Accordingly, I arrested the involved accused persons namely (i) Ajim Majhi (25 Yrs) S/o- Lakhiram Majhi & (ii) Ambuj Majhi (32 Yrs) S/o- Rathu Majhi both of Vill- Shalga Dumdumi, PS- Arsha, Dist- Purulia after maintaining all formalities regarding arrest and NHRC guidelines, issued Arrest Memos after issuing Check List. Informed them regarding the ground of arrest and also informed their family members.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused persons namely (i) Ajim Majhi (25 Yrs) S/o- Lakhiram Majhi & (ii) Ambuj Majhi (32 Yrs) S/o- Rathu Majhi both of Vill- Shalga Dumdumi, PS- Arsha, Dist- Purulia under proper section of Law.
