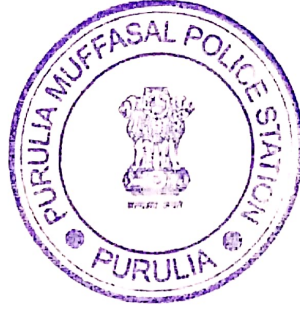

Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested alleged driver namely Karna Bauri (32 Yrs) S/o- Kishan Bauri of Ketika Bauri para, Ward No.- 9, PS- Purulia (T), Dist- Purulia and seized one SODYCO blue colour TOTO without number loaded with approx 01 (One) Ton coal and also taken sample of 02 kg coal from the TOTO.

I beg to state that on 12.11.2023 at about 14:45 hrs while I, SI Aniruddha Chatterjee along with C/- 154 Rajib Nag, HG/1618- Haripada Gorain both of Purulia (M) PS, Dist- Purulia, vide Purulia (M) C.C No- 5161/2023, Dtd. 12.11.2023 and GDE No- 627 Dtd. 12.11.2023 were performing mobile duty at PS area, I received information from my source that one SODYCO blue colour TOTO without number loaded with illegal coal is going towards Purulia Town through Nadiara morh. After receiving the information I contacted you and as per guidance and instruction we left that place to track and stopped this illegal transportation of coal. After a long chase I managed to stop the vehicle near Nadiara Morh on Purulia to Chandankiary Road under Purulia (M) PS at about 15:35 hrs. On seeing the Police party the driver of the vehicle tried to flee away but we managed to apprehend him. On being asked the apprehended person disclosed his identity noted above. On demand he failed to produce any valid document in respect of loaded coal. On preliminary enquiry it could be learnt that the driver of the said vehicle were procuring the said illegal coal from different places and transporting the same in a clandestine manner to another district/state. So, it is reasonable to believe that he was transporting the coal illegally after procuring.

Accordingly I seized the above noted vehicles loaded with coal approx 01 Ton under proper seizure list duly signed by the accompanied Police persons as there was no availability of any local person, as such I could not collect the signature of the local people in seizure list during seizure. I have taken 02 Kg coal from the TOTO as sample after preparing proper level. The seizure was made between 15.45 to 16.05 hrs. I also arrested the above noted accused person at 16.15 hrs after maintaining all formalities regarding arrest. Informed him the ground of arrest and issued Memo of Arrest. After that we made a proper arrangement and brought the arrested accused and seized vehicle loaded with coal at PS for custody.

Therefore, I pray before you that a specific case may kindly be registered against the driver namely Karna Bauri (32 Yrs) S/o- Kishan Bauri of Ketika Bauri para, Ward No.- 9, PS- Purulia (T), Dist- Purulia and the owner of the seized one SODYCO blue colour TOTO without number under proper section of law.
