Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Jaya Mudi (42 Yrs) S/o- Mugru Mudi of Vill- Ledabera, PS- Purulia (M), Dist- Purulia and seized articles 18 (Eighteen) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each, along with seizure list and Memo of Arrest.

I beg to state that today (17.11.2023) while I, ASI Ashish Adhikary along with force (i) C/- 683 Mansaram Rajak & (ii) C/- 1410 Saroj Kumar Patra all of Purulia (M) PS vide GDE No- 846 Dtd. 17.11.2023 are performing mobile duty at about 14.15 hrs I received secret information regarding an illegal possession of a huge quantity of liquors. Subsequently, I informed the matter to you and as per your direction, I rushed to the spot at the shop, situated at Suribandh, beside the pitch road from Purulia to Barakar under Purulia (M) PS and after arriving at the spot and as per your instruction we are conducted raid in the shop at about 14.55 hrs. During the raid some people fled away and apprehended one person. On being asked he disclosed his identity as Jaya Mudi (42 Yrs) S/o- Mugru Mudi of Vill- Ledabera, PS- Purulia (M), Dist- Purulia. On being interrogation he confessed that he procured and stocks said illegal liquors for selling illegally in his shop. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors. Subsequently, I seized 18 (Eighteen) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each. In which 01 sealed bottle taken as samples. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 15.05 hrs & 15.20 hrs.

Accordingly, I arrested the above noted accused person at 15.25 hrs after maintaining all formalities regarding arrest after issuing Check List. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you that kindly take lawful action against the arrested accused person namely Jaya Mudi (42 Yrs) S/o- Mugru Mudi of Vill- Ledabera, PS- Purulia (M), Dist- Purulia under proper section of Law.
