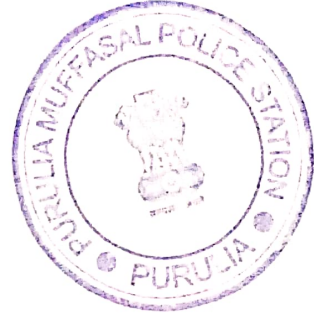

Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Bibhuti Sahis (53 Yrs) S/o- Lt. Prahallad Sahis of Vill- Sihali- Jaleswar, PS- Purulia (M), Dist- Purulia and seized articles 28 (Twenty Eight) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each, along with seizure list and Memo of Arrest.

I beg to state that today 20.11.2023 midnight I, ASI Biswajit Kalindi received secret information regarding an illegal possession of a huge quantity of liquors. Subsequently, I informed the matter to you and as per your direction, myself along with force (i) C/- 851 Amrit Banerjee & (ii) C/- 1137 Sridam Bauri all of Purulia (M) PS vide GDE No- 998 Dtd. 20.11.2023 left PS to work out the information. At about 01.05 hrs while we rushed to the spot, situated at Sihali- Jaleswar village, under Purulia (M) PS and as per your instruction we conducted a raid in the house. During the raid we are apprehended by one person who keeps the liquors in his house. On being asked he disclosed his identity as Bibhuti Sahis (53 Yrs) S/o- Lt. Prahallad Sahis of Vill- Sihali- Jaleswar, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocks the said illegal liquors for selling illegally in his house. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors. Subsequently, I seized 28 (Twenty Eight) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each. In which 01 sealed bottles were taken as samples. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made at 01.15 hrs.

Accordingly, I arrested the above noted accused person at 01.25 hrs after maintaining all formalities regarding arrest after issuing a Check List. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you that kindly take lawful action against the arrested accused person namely Bibhuti Sahis (53 Yrs) S/o- Lt. Prahallad Sahis of Vill- Sihali- Jaleswar, PS- Purulia (M), Dist- Purulia under proper section of Law.
