Sir,

I, SI Abhijit Singha of Purulia (M) PS do hereby submitting complaint against arrested accused persons namely (i) Tajamul Khan (46 Yrs) S/o- Lt. Manir Khan of Vill- Shakra, PO- Shakra, PS- Para, Dist- Purulia (ii) Sk Hussain (33 Yrs) Sk Ahid of Bagandih, PS- Jhalda, Dist- Purulia (iii) Rohit Bit (24 Yrs) S/o- Bubai Bit of Kalyanpur housing 7th Bn. Asansol north PS, Dist- Paschim Bardhaman (iv) Mohammad Samim (23 Yrs) S/o- Md. Jawad of Karbala Sitla, Asansol North PS, Asansol North (M) Crop. Dist- Paschim Bardhaman (v) Md. Saddam (30 Yrs) S/o-Md. Basir Ahmad of Jahangir Mohalla, Asansol North PS, Asansol (M) Corp, Dist-Paschim Bardhaman and also producing seized articles (i) One Pick up Van having Reg. No. WB 37E 5524 loaded with 07 (Seven) buffaloes (Kara) (ii) One vehicle (Eicher Pick up Van) having Reg. No. WB 37E 5650 loaded with 06 (six) buffaloes (Kara) (iii) One vehicle (Pick up Van) having Reg. No. WB 55A 7924 loaded with 08 (eight) buffaloes (Kara) (iv) One vehicle (Pick up Van) having Reg. No. WB 17M 1775 loaded with 06 (six) buffaloes (Kara) (v) One vehicle (Pick up Van) having Reg. No. JH 09AU 0207 & (vi) 24 (Twenty Four) numbers of buffaloes standing there to be transported and arrest memos, seizure lists and check list.

I beg to state that today (20.11.2023) during my mobile duty vide Purulia (M) PS GDE No-1012 Dtd. 20.11.2022 on Purulia-Ranchi road with Govt vehicle and at about 12:45 hrs I, received a credible source information from a reliable person that some persons were loading buffaloes illegally without any valid documents or proper permission from concern authority in 03-04 vehicles near Chas more. Accordingly, I intimated the matter to I/C Purulia (M) PS and as per his kind instruction I along with my accompanied force C/- 851 Amrit Banerjee & C/-1137 Sridam Bauri all of Purulia (M) PS rushed at Mouza Sindri Chas morh Bazar Tanr near Huda morh under Purulia (M) PS and found there are 05 vehicles having reg. numbers (i) WB 37E 5524 (ii) WB 37E 5650 (iii) WB 55A 7924 (iv) WB 17M 1775 & (v) JH 09AU 0207 and out of these four vehicles loaded with buffalos and one empty vehicle as per seizure list. There were 24 (Twenty Four) buffaloes which were about to be loaded for transportation. There were some persons who were engaged in the said loading. When they saw the Police Party, they ran here and there to escape. We chased them and managed to detain 05 persons. I interrogated them thoroughly and after prolonged interrogation they revealed their identity as noted above but their identities could not be verified as they could not produce any relevant document in respect of their addresses and ages. On demand, they could not produce any valid papers in respect of the vehicle or the Cattles, and about the procurement of cattle or vehicle. Not only that they also could not produce any paper regarding transportation of the Cattles. The vehicle was not meant for transporting livestock as no livestock permit was available. They did not give satisfactory reasons for transporting of Cattles by vehicles. They have stated incoherently and from their statements there is every reason to believe that they have procured the vehicle and cattle by any fraudulent means or by means of theft also the cattle were illegally being transported to other states for the purpose of illegal inter-state cattle smuggling for their wrongful gain. On interrogation it is also revealed that they have been in this transportation of cattle since long and

voluntarily assisting in smuggling of cattle. Moreover, they confined those cattle in the vehicle which did not measure sufficiently in height, length, and breath to permit the animal a reasonable opportunity for movement.

Hence, I have seized those total 51 (Fifty One) buffaloes and the 05 (Five) vehicles noted above from the possession of the above noted accused persons under proper seizure list and after seizure I also arrested them as mentioned above as they committed offence U/S-379/413/414/120B IPC and section 11(1)(d)(e)(f) of the Prevention of Cruelty to Animal Act 1960 by maintaining all formalities regarding arrest. It is to be noted here that we were waiting for a public witness Puland after a lapse of time no public witness could be available there and hence my accompanying Police party stood as seizure witness.

I, therefore pray before you that a specific case may kindly be register against the arrested accused persons namely (i) Tajamul Khan (46 Yrs) S/o- Lt. Manir Khan of Vill- Shakra, PO- Shakra, PS- Para, Dist- Purulia (ii) Sk Hussain (33 Yrs) Sk Ahid of Bagandih, PS- Jhalda, Dist- Purulia (iii) Rohit Bit (24 Yrs) S/o-Bubai Bit of Kalyanpur housing 7th Bn. Asansol north PS, Dist- Paschim Bardhaman (iv) Mohammad Samim (23 Yrs) S/o- Md. Jawad of Karbala Sitla, Asansol North PS, Asansol North (M) Crop. Dist- Paschim Bardhaman (v) Md. Saddam (30 Yrs) S/o- Md. Basir Ahmad of Jahangir Mohalla, Asansol North PS, Asansol (M) Corp, Dist- Paschim Bardhaman and the owner of vehicles (i) WB 37E 5524 (ii) WB 37Ē 5650 (iii) WB 55A 7924 (iv) WB 17M 1775 & (v) JH 09AU 0207and others under proper sections of Law.
