Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Rahul Mahato (26 Yrs) S/o- Shaktipada Mahato of Vill- Sindri Namopara, PS- Purulia (M), Dist- Purulia and seized articles 17 (Seventeen) numbers of sealed bottles of DIL SE' containing 600 ml each and 02 (Two) Litters illicit distilled liquors along with seizure list and Memo of Arrest.

I beg to state that today (23.11.2023) while I, SI Soumen Kr. Panda along with force (i) C/- 683 Mansaram Rajak & (ii) C/- 1410 Saroj Kumar Patra all of Purulia (M) PS vide GDE No- 1223 Dtd. 23.11.2023 are performing mobile duty at about 18.35 hrs I received secret information regarding an illegal possession of a huge quantity of liquors in a shop of Sindri village. Subsequently, I informed the matter to you and as per your direction, I rushed to the spot at the shop, situated at Sindri Namopara village under Purulia (M) PS. After arriving at the spot and as per your instruction we conducted a raid in the shop, at about 19.15 hrs. During the raid some people fled away and apprehended one person. On being asked he disclosed his identity as Rahul Mahato (26 Yrs) S/o- Shaktipada Mahato of Vill- Sindri Namopara, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocks illegal liquors for selling illegally in his shop. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors. Subsequently, I seized 17 (Seventeen) numbers of sealed bottles of 'DIL SE' containing 600 ml each and 02 (Two) Litters illicit distilled liquors. In which 01 sealed bottle taken as samples from 'DIL SE' and 500 ml taken as sample from the illicit distilled liquors. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 19.25 hrs & 19.40 hrs.

Accordingly, I arrested the above noted accused person at 19.45 hrs after maintaining all formalities regarding arrest after issuing a Check List. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you that kindly take lawful action against the arrested accused person namely Rahul Mahato (26 Yrs) S/o- Shaktipada Mahato of Vill- Sindri Namopara, PS- Purulia (M), Dist-Purulia under proper section of Law.
