Most respectfully begs to state:-

- 1. That the Complainant Binod Kumar Singhania, S/O- Late Govind Prasad Singhania, a resident of Nathu Babu Lane, Chowk Bazar, P.O. Purulia, P.S. Purulia(T), Dist- Purulia, West Bengal, Pin- 723101 was called upon on 14.08.2023 at about 3:00 P.M by one Manish Kumar Singhania, S/o- Sri Banwarilal Singhania, of Nathu Babu Lane, Chowk Bazar, Purulia Municipal Ward No. 13, P.O- Purulia, P.S- Purulia (T), Dist- Purulia, i.e., the accused no. 1, in his office with a request to have a discussion regarding common a passage.
- 2. That when the Complainant Binod Kumar Singhania entered into the office of the accused no. 1 he found that Banwarilal Singhania, S/o- Late. Govind Prasad Singhania i.e., accused no. 2, and Rinku Singhania, W/o- Manish Kumar Singhania, i.e., accused no. 3 both are resident of Nathu Babu Lane,



Chowk Bazar, Purulia Municipal Ward No. 13, P.O- Purulia, P.S- Purulia (T), Dist- Purulia, were also present in the office of the accused no. 1.

- 3. That all the accused persons no. 1, 2 and 3 by hatching a criminal conspiracy, put the Complainant Binod Kumar Singhania in fear of death and grievous hurt asked him to put signatures on some papers in order to deliver the right of common passage in their favour, and when he denied to put his signatures on those papers, the accused nos. 1, 2 and 3 suddenly become violent and started to abuse him in filthy languages and assaulted him by fist and blows and Manish Singhania, i.e., accused no. 1 pressed his neck in order to kill him by saying "saala tumko jaan se hi maar denge", Banwarilal Singhania, i.e., accused no. 2 hit him on his chest by a lathi and Rinku Singhania, i.e., accused no. 3 threatened him to put his signatures on those papers, failing which he will be implicated in a case of outrage of modesty.
- 4. That when the Complainant Binod Kumar Singhania made hue and cry, Hemanta Mahato, Basanta Mahato and Mujtaba Rahaman, i.e., the witnesses nos. 2, 3 and 4 came to rescue the Complainant, and the accused nos. 1, 2 and 3 fled away from the place and with the help of local persons the Complainant was taken and admitted into Deben Mahato Government Medical College & Hospital, Purulia.
- That after treatment, the complainant had been to the Purulia (T) P.S in order to lodge a complaint, but the duty officer refused to accept the same, accordingly the complainant posted the complaint through registered post on 12.09.2023 and the same was received by the concerned P.S on 13.09.2023, but after receiving the same no action has been taken by the police station.
- 6. That subsequently, the Complainant on 18.09.2023 informed the matter to the Superintendent of Police, Purulia but even then as no step has been taken against the Accused Persons by the police, the Complainant is being compelled to lodged this Petition u/s 156 (3) Cr.P.C. before Your Honour's Court.



It is therefore prayed that your Honour will be graciously pleased to send this petition to Inspector-in-charge of Purulia (T) P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr. P.C. and to investigate the case in accordance with law and to unearth the wrongdoer
