Sub: Prayer for starting a specific case U/S- 285/286/188 IPC & Sec 24/26 of  
West Bengal Fire Service Act.

Sir,

In producing herewith one accused persons namely Ganesh Agarwal, S/O Lt. Ashok Agarwal of- Shyampur, Anara RS, PS- Para, Dist- Purulia in custody, along with proper memo of arrest in original and with the following seized articles as per original seizure list that is (i) 100 Packets of SRI VEL Turkey Bijili Fire Works each containing 100 Pcs. (100x100 pcs) (ii) 20 Packets Trade Mark Rolex Chocolate Bomb, Each containing 12 pcs. (20x12 pcs), (iii) 10 Packets Supreme Aeromatic Rocket, each containing 15 Shells (10x15 pcs), (iv) 50 Box of Black Cat Chocolate Bomb, Electric Sound, each box contains 10 Pcs (50x10 pcs), (v) 20 Box Top 5 Sky Wonders each containing 05 Pcs (20x05 pcs).

That today 04.11.23 at 14:15 hrs. while I ASI Joydeb Atta along with force (1)C/2813 Uttam Kr. Ahir and (2) C/1252 Sunil Kr. Mondal was engaged in 2<sup>nd</sup> Spl. Mobile duty vide Purulia Town PS GDE No. 228 dated 04.11.2023 and CC No 3748/23 I received a reliable source information that a person namely Ganesh Agarwal is selling huge quantity contraband high noise and air polluting fire crackers at Kalitala Lane under Purulia (T) PS which are banned to sell and purchase to public as per order of High Court, Calcutta. I immediately informed the matter to I/C Purulia Town PS and as per his direction I moved to Kalitala Lane After arriving at Kalitala Lane I found that a person was selling contraband high noise and air polluting fire crackers which are banned to sell and purchase to public as per order of Ld. High Court, Calcutta, by showcasing the above mentioned fire crackers on a table in front of an unnamed shop at Kalitala Lane On being asked, he disclosed himself as Ganesh Agarwal, S/O Lt. Ashok Agarwal of- Shyampur, Anara RS, PS- Para, Dist- Purulia and also stated that the above mentioned fire crackers were displayed over for sale purpose and to attract customers. He also confessed that he is the owner of the unnamed shop behind him and he has kept huge quantity of high noise and air polluting fire crackers in that shop as well. On demand he could not produce any documents and permission of such huge quantity high explosive fire crackers and air polluting fire crackers. On holding raid at the unnamed shop behind I found huge quantity of Fire Crackers as mentioned above.

So, there was reasonable ground to believe that the above noted person who claimed himself the of the owner of the unnamed shop was selling the articles i.e. contraband firecrackers and fireworks illegally without any proper license or permission, endangering the human life near residential buildings which may likely to cause hurt or injury to any person without any proper guard which is sufficient enough to cause any probable danger to human life from those substance and has also violated the order of Ld. Hon'ble High court.

Accordingly, I have seized aforesaid huge quantity of illegal firecrackers and fireworks under proper seizure list in between 14:35 hrs to 15:05 hrs duly signed by the witnesses and the accused person. Hence, I arrested him after conveying him the ground of arrest and issued proper memo of arrest.

Under the above noted facts and circumstances, I am submitting a typed complaint against the accused person noted above who is also the owner of the unnamed shop with a request to start a specific case against him U/S 285/286/188 IPC & Sec 24/26 of West Bengal Fire Service Act and arrange for its investigation.
