Purulia(T), Purulia-723102, for his vandalism attitude and reckless driving, resulting death of Aritra Ghosh, S/o Shri Sanjoy Ghosh, of near 40 Quarters, Ward No.06, Dulmi-Nadiha, P.S. Purulia(T), Dist – Purulia-723102.

Sir,

With utmost concern it is to intimate before your kind concern that, I, Shri Sanjoy Ghosh, S/o Late Manilal Ghosh, of near 40 Quarters, Ward No.06, Dulmi-Nadiha, P.S. Purulia(T), Dist – Purulia-723102 wish to lodge a complain against Sri Soumyajit Chandra, S/o Shri Prashanta Chandra, resident of Prantik Gali, Mistimahal, P.O. Dulmi-Nadiha, P.S. Purulia(T), Purulia-723102.

Sir, it is quite disappointing to mention here that in our locality some reckless biker group are creating nuisance to the society which may intolerable to us nowadays.

In connection with this matter Myself personally requested just 8 to 10 days before to the kingpin of this biker group, namely Sri Soumyajit Chandra, S/o Shri Prashanta Chandra, resident of Prantik Gali, Mistimahal, P.O. Dulmi-Nadiha, P.S. Purulia(T), Purulia-723102, not to drive bike recklessly in the locality which may cause severe loss to anybody.

After that conversation, on 31.10.2023, Tuesday, at about 09.30 a.m., my only son Aritra Ghosh, was returning from Hanuman Mandir of Purulia Zilla School More with his bicycle after worship from the said mandir, on that said time near Nadiha Gymnastic club suddenly a heart throbbing accident took place. The Motor cycle rider who hit my son Aritra is non other than the said kingpin of that biker group, riding his Pulsor NS 200 bike, having registration no. WB56P 6716, at over speed, not only that the said bike was being driven in a zigzag manner.

The impact was so intense due to high speed that Aritra was thrown into the air about 10-15 feet and he suffered severe head injury. After the incident Aritra immediately admitted to Purulia Deben Mahato Sadar Hospital in a senseless condition. The Doctors of Purulia Deben Mahato Sadar Hospital, advised for better treatment and to shift Aritra to any better Multi Speciality Hospital. Later my son Aritra admitted to K.M. Memorial Hospital, Chas, Bokaro but as per instruction of neuro surgeon, on that same day he shifted to Bokaro General Hospital for better observation.

Atlast on 03.11.2023, around 06.00 p.m. my son Aritra died at Bokaro General Hospital due to severe brain injury caused by the reckless and high speed bike driving by Shri Soumyajit Chandra.

Sir, in that whole aforesaid matter I would like to request you to kindly lodge a FIR against the killer of my only son Aritra, and take a strict legal action against him.

Your kind sympathetic action in this regard may highly be solicited.


