I the undersigned would like to inform you that on 05.11.2023 at about 12:30 AM, S^{/o}-Lt. ^{S/o-Lt. Tarishwar Ganguly} Sukumar Ganguly, and Arnab Kanti Ganguly, S/o - Sri Sukumar Ganguly, of Sukal Pally, Desh Bandhu Road Bye Lane, Po - Purulia, Ps:- Purulia (Town), Dist - Purulia, Suddenly entered into our house by jumped over the boundary wall and started to abused me in filthy languages and when I protest about such activities at overnight, they suddenly became more violent and started assaulted me in brutal manner with fist and blow and kicked on my abdomen, hearing the hulla when my old aged ailing father try to escape me, at that time Arnab Kanti Ganguly hit on my eye with the help of a iron made Pinch with an intention to kill me and somehow I managed to escape and they also assaulted my father and pelt Stone on my hand. Hearing our voice, when the neighbors namely Jambu Bawali, Goutam Baori, Raja Ram and some others came to our house, then the above name wrongdoers fled away. Due to such assault myself and my father sustained injuries and I was treated at Deben Mahato Medical College and Hospital, Purulia, in emergency ward.

In this regard you are requested to take every legal action against the wrongdoers by which they can be punished in accordance with law.
