
- 1. That on 21/8/23 at about 3:00pm the complainant of this case namely Sajnu Kazi, s/o Kali mohammad Kazi aged about ½ years of village- Bursha, Beldih, PS- Arsha, Dist Purulia (complainant) along with his co- villager Hasibul shek s/o Sishu mahammad Shek went to shopping at Raju Variety store near chawkbazar area.
- 2. That all the accused person namely Rani Parbin, d/o Abam Osta, w/o Sajnu kazi ,Alam Osta, S/O Late Asraf Ali Osta ,Salma Bibi , W/O Abam Osta. ,Pappu Sekh , S/O Late Jumon Sekh. ,Chotu Sekh , S/O Late Jumon Sekh. ,Resma Bibi , D/O Late Jumon Sekh, Rasida Bibi (Meheruna / Aunty)., Khabiran Bibi W/o Chutli Sekh ,and Wife of Late Jumon Sekh., All of Address Rajbasti near masjid , JK College Road, Purulia. After getting information from their source Confronted and and co-villager Hasibul Shek in front of public
- 1. That salma bibi w/o Alam Osta and Alam Osta s/o late Asraf Ali Osta himself, resident of vill- Bursha, instigated other above stated accused persons and all of the stated accused persons started assaulting the complainant in public and started beating the complainant and used filthy languages due to previous grudge.
- 2. That the complainant had went for shopping in Raju varieties store and he had Rs 30,000 in his pocket, the above stated all the accused persons hatched criminal conspiracy and snatched the above mentioned money from his pocket and took those money from him with mal intention, and at at point of time khabiran hibi. Pachida



- 3. That the accused persons made mass attack to kill the complainant and the complainant wouldnot resist the outnumbered and repeatedly begged for mercy. Hasibul shek also repeatedly preyed for mercy but the accused person failed to do so and continued with their activities.
- 4. The complainant somehow managed to escape with the help of passerby and saved his life from them.
- 5. That all of the above named accused person threatened to kill the complainant and throw him in the nearby jungle where no trace of complainant will be found.
- 6. The complainant out of fear to save himself from the above name accused locked himself in a room of his house and for this reasons there are a little delay in lodging this complaint.
- 7. That all the above named accused person with their common intention with the help of each other assaulted the complainant mercilessly with fist and blow as a result the complainant sustained injury and the female folk from the side of the accused caught hold of the complainant and helped their family members to commit such kind of brutal, inhuman, merciless activities.
- 8. That after coming out of the fear the complainant went to the Police station to file a complaint but they refused to receive any complaint.
- 9. That the accused persons have committed an offence under various sections of IPC
- 10. That the defacto complainant lodged this complaint to the concerned PS but the IC Purulia sadar PS did not take any action against the present accused persons nor he lodged any FIR in respect of the said complaint in several occations, then on 13/9/23the complainant further
