Most respectfully begs to state:-

- 1. That the Complainant and the accused persons are residing at their respective houses situated within the District of Purulia, P.S. Purulia (T), and within the jurisdiction of this Ld. Court.
- 2. That one Md. Nazir Hussain, S/o- Late. Md. Hussain, a resident of Simulghuta, Telkolpara, Purulia Municipal ward No. 11, P.O- Namopara, P.S- Purulia (T), Dist- Purulia, being the attorney holder of Sri Raja Sahis, S/o- Late. Bhikhu Sahis, a resident of Sinderpatty, Rail quarter, Purulia Municipal Ward No. 11, P.O- Namopara, P.S- Purulia (T), Dist- Purulia, and Debabrata Ghoshal, of Gour Mohan Kar lane, Napit Para, P.O- Namopara, P.S- Purulia (T), Dist- Purulia, i.e the accused persons, approached the complainant and her husband for selling a piece of land which is within the



municipal area and also represented the complainant and his husband that the land will be perfect for residential purpose and the price is also very low.

- 3. That as the complainant and his husband were searching for a piece of land for raising construction of a house as per their dreams, seeing the persistent approach and relying upon the representation made by the accused persons, agreed to purchase the land measuring an area of 2 katha 8 chhatak within Purulia Municipal ward No. 16, within Mouza- Purulia being R.S Khatian No. 707, R.S. Plot No. 2229 and 2434 and consideration was fixed at Rs. 5,80,000/- per katha, and the complainant entered into an unregistered agreement for sale of the property, with said Nazir Hussain on 18.02.2023, and at the time of agreement said Nazir Hussain assured the complainant and his husband to provide all the relevant documents with respect to the said property and the complainant have paid a sum of Rs. 1,50,000/- (One Lakh Fifty Thousand) cash towards advance amount on the date of signing of the agreement i.e on 18.02.2023. Subsequently, in the first part of March, 2023, said Nazir Hussain asked the complainant to give a further sum of Rs. 1,00,000/- (One Lakh) towards further advance and for the expenses towards registration process and on that day the husband of the complainant again asked the accused persons to provide the copy of land related documents, but the reason best known to them, they neglected the same with some excuse and out of 1,00,000/- the accused persons received a sum of Rs. 46,000/- and asked the complainant and her husband to give the balance amount in the evening of the same day.
- 4. That thereafter, the complainant along with her husband made several requests to supply the necessary documents which constitute the absolute marketable title of the accused person Raja Sahis, free from all encumbrances, as well as asked the accused persons to identify the ground position of the land, as the stipulated period of the agreement for sale was going to be lapsed shortly. But said Nazir Hussain and Debabrata Ghoshal, instead of supplying the necessary documents, send a lawyer notice to the complainant as well as to her husband on 17.04.2023 i.e just on the date of expiry of the stipulated period of the agreement for sale with some false and frivolous grounds and also asserts that the advance money paid by the complainant will be forfeited.



- Hussain, in collusion Raja Sahis, Debabrata Ghoshal and some others, by hatching a conspiracy with intend to deceive the complainant, execute an agreement for sale and received a sum of Rs. 1,96,000/- cash on several occasion, and inspite of supplying the necessary documents with respect to the aforesaid land, with some ill motive and in order to hush up the money of the complainant, sent lawyer notice and misappropriated such sum and refused to supply documents as well as execute deed of conveyance in favour of the complainant and thereby committed the offence of cheating, mis appropriation of money, causing wrongful loss to the complainant and wrongful gain to themselves, and thereby committed several other offences punishable under the law.
- 6. Sir the above-mentioned matter was duly intimated to the Inspector-incharge of Purulia (T) P.S on 05.07.2023, and Purulia (T) P.S GDE No. 289 dated. 05.07.2023 was provided, but the reason is best known to them, even after elapsed of more than one and half month, no action has been taken from the end of Purulia (T) P.S, hence, seeing no alternative as well as no action on the part of Purulia (T) P.S.
- 7. That subsequently, the Complainant on 29.08.2023 informed the matter to the Superintendent of Police, Purulia but even then as no step has been taken against the Accused Persons by the police, the Complainant is being compelled to lodged this Petition u/s 156 (3) Cr.P.C. before Your Honour's Court.

It is therefore prayed that your Honour will be graciously pleased to send this petition to Inspector-in-charge of Purulia (T) P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr. P.C. and to investigate the case in accordance with law and to unearth the wrongdoer
