Subject: - FIR against Gangadhar Mahato(user), Fathers name Ajit Kumar Mahato, resident of North Lake More (Raghabpur More), Purulia(T) thana , Dist Purulia.

Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed unauthorized reconnection of disconnected line U/S 138 (1) (b) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 09/11/2023 at 13.50 Hrs. I Sri Subhajit Pratihar DE & SM Purulia CCC WBSEDL along with Partha Chakraborty (DE attached to Purulia Regional Office WBSEDL) ,Promod Ranjan Barman (Special officer attached to Purulia Regional Office, Chinmay Maity (JE Purulia CCC) and Dayamay Mahato (Sr TSH Purulia Region Office WBSEDL) went to make an inspection to workout upon a source information regarding unauthorized reconnection of disconnected line in the premise of Gangadhar Mahato(user), Fathers name Ajit Kumar Mahato, resident of North Lake More (Raghabpur More) ,Purulia(T) PS, Dist Purulia .

It was observed that accused Gangadhar Mahato(user) has made unauthorized reconnection of disconnected line under section 138 (1) (b) of the electricity Act 2003, Amendment of 2007 by reconnecting the disconnected service cable himself (Consumer Name – Mrityunjoy Mahato, consumer id 242117226, meter no 7S0281369) from the pole by some means and used electricity without paying the outstanding electricity bill and he was using 2 nos LED bulb and 1 no ceiling fan. The meter was found defective at the time of inspection. The estimated loss of the organization WBSEDL in this regard is 855 kwh .

After detection of unauthorized reconnection of disconnected line illegally and dishonestly, the inspection team disconnected the service connection from the pole, removed & seized a portion of the service cable with the help of LT Mobile Van Team.

The inspection team left the premises at about 14.15 Hrs on 09th November 2023.

The accused committed theft of electricity U/S 138 (1) (b) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
