In producing herewith one arrested aced. Person namely Turk Abdul @ Abdul Turk Saha (43 yrs) S/O- Late Turk Ladu @ Ladu Turk Saha of Near Maszid Musalim Vestar, Baroi, Kachchh, Baroi, Gujrat, 370421 A/P- Vill- Damda, P.O- Simulia, P.S- Tamna, Dist- Purulia along with seized articles i.e (1) One black colour old Money Purse (2) One Aadhaar Card of Turk Abdul having Aadhaar No-521900611955 (3) 02(two) pieces of five hundred Rupee (Rs-500/-) having no 70D336044 & 70D336046 (All notes seems to be faked) under proper seizure list.

I ASI Tapan Kr. Mahanti of Purulia (T) PS lodged this complaint against the above noted accused person to the effect that today on 16.11.2023 at 03:05 hrs while I engaged in Night Mobile Duty vide GDE No- 982, and CC No- 2461/23, Dated- 15.11.2023 received a secret source information that one person of Gujrat is presently staying as tenant for some days at Katin Para under Purulia (T) PS for dealing with FICN at Purulia area to circulate FICN in a business deal. On receipt of that information I informed to I.C Purulia (T) P.S and as per his direction I decided that myself along with C/1252 Sunil Kr. Mandal, HG/333 Nakul Gorain all of Purulia (T) P.S will go to that place. Accordingly at about 03:15 hours we left to work out the information. At about 03.35 hrs myself along with force reached at Katin Para and found that one person of Gujrat staying at lonely rented house. On being asked he start different statement in different time which was suspicious to me. After a long interrogation he disclosed his identity as noted above. During search on him in presence of witnesses following articles i.e. (1) One black colour old Money Purse (2) One Aadhaar Card of Turk Abdul having Aadhaar No- 521900611955 (3) 02(two) pieces of five hundred Rupee (Rs-500/-) having no 70D336044 & 70D336046 (All notes seems to be fake) which were kept in his back side pant pocket are found. On being asked about those currency notes (seems to be faked) he could not give any satisfy answer in respect of possession of such notes. At last he confessed that he deals with Fake currency notes and he came to Purulia to show the sample notes to his other agents, after conformation of deal he supply the bulk amount of fake currency. Some persons are involve in the trafficking of forged currency notes in Purulia district to dispose the same to another who will transform the fake currency as genuine. He confessed that he has been involved in the racket

Then I seized (1) One black colour old Money Purse (2) One Aadhaar Card in the name of Turk Abdul having Aadhaar No- 521900611955 (3) 02(two) pieces of five hundred Rupee (Rs-500/-) having no 70D336044 & 70D336046 (All notes seems to be faked) under proper seizure list in presence of the available witnesses of raid parties as Alamat of the case. Copy of the seizure list was given to the accused person acknowledging in the seizure list. After seizure all the seized articles were sealed and labeled properly in presence of the witnesses and the accused person. I am to note here that there is no any public witness present due to that odd time. Seizure, Labeling were made in between 03.55 hr and 04.05 hrs.

Then I arrested the accused person informing the ground of arrest by issuing memo of arrest at 04.15 hrs. After arrest we moved nearby areas in search of the other agents who had a plan buy and to circulate FICNs from them. But we could not locate them; probably they had got the smell of police raid.

Therefore, I request you to initiate a case U/S-489A/489B/489C/120B IPC against Turk Abdul @ Abdul Turk Saha (43 yrs) S/O- Late Turk Ladu @ Ladu Turk Saha of Near Maszid Musalim Vestar, Baroi, Kachchh, Baroi, Gujrat, 370421 A/P- Vill- Damda, P.O- Simulia, P.S- Tamna, Dist- Purulia & other associates.
