Sir,

In producing herewith the arrested accused person namely (1) Prasanta Mosan (33y/M) S/O Lt. Sudhir Mosan Vill- Kajladih, P.O- Sibpur, PS- Kanksa, Dist-Paschim Bardhman driver of Dumper having Reg. No. WB37E/4369 loaded with sand measuring 1170 Cft. (2)Sandip Bauri (30y/M) S/O Bamapada Bauri Vill- Binui, P.O- Nabasan, PS- Kankartala, Dist- Birbhum driver of Dumper having Reg. No. WB37E/3317 loaded with sand measuring 1130 Cft. and (3) Prasanta Bauri (32y/M), S/O Ajit Bauri Vill- Meherpur, P.O- Nabasan, PS- Kankartala, Dist- Birbhum driver of Dumper having Reg. No. WB37E/4241 loaded with sand measuring 1160 Cft. Fact of the case in brief is that on 20.11.2023 I along with C/11 Kajal Mukherjee and HG/222 Alok Bauri both of Purulia Town PS were performing Night Mobile Duty at PS area vide Purulia (T) PS GDE No- 1182 dated 20.11.23 and C.C. No. 3511/23. At about 07:55 hrs received source information that the above noted dumpers loaded with sand were coming from Raghunathpur side. After receiving such information I informed the matter to IC Purulia Town PS vide Purulia (T) PS GDE No-1194 dated - 20.11.2023 and as per his kind direction we had been to Judge Banglow More, Ranchi Road under Purulia (T) PS and waiting for the said dumpers and at about 10:45 hrs found that the above noted dumpers are coming from Goshala More side. We stopped the said dumpers and on searching it is found that the said dumpers were loaded with sand and on asking drivers of the said dumpers failed to produce any papers in respect of loaded sand as well as papers in respect of the said dumpers. Accordingly I informed the matter to I/C Purulia (T) PS and as per his instruction I give them some time or chance if they can produce any valid papers in this respect in any way. In the meant time I sent a requisition before the BL & LRO Purulia-I to verify the measurement (CFT) of the sand loaded dumpers through messenger. As soon as the Revenue Inspector of Sonaijuri Gram Panchayat, Purulia measured the sand loaded dumpers and supply its Enquiry report. After that I gave them last chance to produce relevant documents but they could not produce any documents till 12:00 hrs (21.11.2023). They also made incoherent statement in respect of possession of the said sand in their dumpers which they were driving. So, it is reasonable to believe that the drivers and owners of the said dumpers collected the said sand either by theft or by any fraudulent

means from anywhere and transporting the same to run clandestine business for wrongful gains. On interrogation the drivers of the said dumpers confessed their guilt. As such it is every reason to believe that the drivers and owners of the said dumpers Reg. No. WB37E/4369, WB37E/3317 and WB37E/4241 are transporting sand illegally. As such I seized the said dumpers having Registration No. WB37E/4369, WB37E/3317 and WB37E/4241 loaded with sand as per measuring report of Revenue Inspector of Sonaijuri Gram Panchayat, Purulia under proper seizure lists duly signed by the accused drivers as well as witnesses. No public witness was available there. Out of which approx 01 (One) K.G. Sand seized from each dumpers as sample & also labeled. Thereafter I arrested the accused drivers of above noted dumpers namely (1) Prasanta Mosan, (2) Sandip Bauri and (3) Prasanta Bauri after observing all formalities and narrating them the ground of arrest.

I therefore pray before you, kindly lodge an FIR against the drivers namely (1) Prasanta Mosan (33y/M) S/O Lt. Sudhir Mosan Vill- Kajladih, P.O- Sibpur, PS-Kanksa, Dist- Paschim Bardhman (2) Sandip Bauri (30y/M) S/O Bamapada Bauri Vill-Binui, P.O- Nabasan, PS- Kankartala, Dist- Birbhum dand (3) Prasanta Bauri (32y/M), S/O Ajit Bauri Vill- Meherpur, P.O- Nabasan, PS- Kankartala, Dist- Birbhum and owners of the dumper bearing Reg. No WB37E/4369, WB37E/3317 and WB37E/4241 as per law and arrange for its investigation.
