I the undersigned, beg to submit that today i.e. on 29-11-2023 at about 12:30 PM when my mother was only present at home, she called me and informed me over telephone that just a while ago two unknown persons came to house and introduced themselves as cleaners of utensils and Jewellery. My mother told them to go away but they requested my mother persistently and for demonstration took two gold bangles from my mother, they put those bangles (weighing about 4 bhois) into a pot which was filled with water. They asked my mother to boil the water, my mother went inside the ~~Kitchen~~ Kitchen to boil water and after boiling she found that those bangles were not in that pot. She screamed and ran to those unknown persons but she did not find them there, she came outside of house and search them, but they fled away.


On this way those two unknown persons took away two gold bangles of my mother after deceiving her. My mother narrated whole story to me.
