I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that (i) Swapan Kumar Majee (present user), (ii) Bhuban Chandra Majee (present user) were enjoying electricity unauthorisedly i,e. bypass of energy meter by cutting of incoming service connection cable and due to this reason they had committed theft of electricity u/s 135 (1)(b) of the Electricity (Amendment Act-2007).
