Santaldih, District- Purulia beg to state that I am the founder and president of the Deben Mahato Teachers' Training Institute for imparting teachers training of B.Ed education affiliated to the Baba Saheb Ambedkar Education University (BSAEU) which is run since long years. There are so many teachers and non-teaching staffs in the said college.

Since sometime past several persons namely 1) Dharanidhar Pati son of Bipattaran pati of Village- Kumrabad, P.O.- Kaliabasa, P.S.- Hura, District- Purulia, 2) Dijapada Mahato, 3) Dhiren Mahato both sons of late Salabat Mahato of village and post-Deoli, P.S. Santaldih, District-Purulia, 4) Chinibas Mahato son of Purna Mahato of village and post-Deoli, P.S. Santaldih, District-Purulia along with their other associates have been trying to take forcefully possession of the institute illegally are doing various and unsocial activities resulting instituting several cases. Before few days it has come to my notice that the lock of the office of my said B.Ed College was changed and the lock given by my staff in the office was broken. On 06/11/2023 the SDPO of Raghunathpur Sub-Division had been to investigate an illegal crime at that time I myself and my teachers namely 1) Dr. Sudipta Mahato 2) Biswajit Bhattacharjee 3) Soumabrata Bhunia 4) Atanu Banerjee 5) Radhamadhab Das 6) Chandan shit 7) Bablu Kumar Bera 8) Susanta Mandal and Non-teaching staffs namely 1) Bhagya Rajwar 2) Anadi Bauri 3) Shaktipada Mahato 4) Rasbihari Mahato 5) Mahadeb Choudhury 6) Ananda Choudhury 7) Bhagirath Rajwar 8) Sunil Gorain 9) Mithilesh Singh 10) Sanjay Singh 11) Prabhas Mahato were present. The above said Dharanidhar Pati and other named miscreant criminally trespassed into the office, damaged the lock and other valuable documents and materials and stolen away those have committed serious offence. Said Dharanidhar Pati and three others named above also admitted & confessed there guilt before the SDPO Raghunathpur that they had damaged the above mentioned electrical materials & almirahs & stolen away the CCTV hard disk & others only to conceal & to destroy the evidence of the actual incident.

I being an old man and on panic filing this complaint before your good self and request you to take action under the appropriate law against the miscreants and see that they are punished in the court of law.

And for which act of kindness I shall be ever grateful to you.
