Officer-in-charge Santuri P. S. Dist.- Purulia The humble petition on behalf of the complainant Most respectfully state as follows:-

1. That the complainant and the acced. persons are the inhabitants of the same village and residing within the jurisdiction of the Ld. court.

2. That on 15-07-23 the complainant was out of Station due to work and his family members that is wife and his son were also not present in the house and taking this advantage the complainant's inhabitants namely Rabilal Soren S/O Lt. Kalicharan Soren and Tarapada Paramanik S/O Lt. Shyam Charan Paramanik set fire in the house of the complainant due to village party notitics and also some previous grudges and after getting the information from the Villagers the complainant returned to his house on 16-07-23 early in the morning and he saw the entire house alongwith all materials i.e. valuable documents, furnitures, utensils everything was destroyed due to fire.

3. That few days before from the date of incident the above named accused persons abusing filthy languages to the complainant and also threatened him to set fire into the house of the complainant and also ruined his family as such the complainant has confirmed that the above named acced. persons have set fire into his house in absence of the complainant as well as his family members.

4. That after this incident the complainant informed the matter to the Santuri P.S. and filling a written complaint but the concerned P.S. did not take such complaint and denied to lodge any complaint against the above name acced. persons as the acced. persons are very much influencial in the locality and subsequently the complainant had to take shelter before the S.P. Purulia but no frutful result. As a result of this


