I SI Sourav Kanti Das S/O- Nirmal Kumar Das of Town colony, V university, PS- Kotwali, Dist- Pachim Medinipur at present posted under Tamna PS, Dist- Purulia as SI of Police in producing herewith the arrested alleged persons namely (i) Pasupati Rajwar (60 Yrs) S/O- Lt. Shyamal Rajwar (ii) Kalipada Rajwar (50 yrs) S/o- Lt. Shikdar Rajwar both of Vill- Parbahal, (iii) Ramanath Rajwar (56 Yrs) S/O- Lt. Badi Rajwar of Vill- Gamariya, (iv) Sukdeb Rajwar (42 Yrs) S/o- Lt. Rathu Rajwar (v) Bhagirath Roy (46 yrs) S/O- Lt. Kalchar Roy both of Vill- Ghoragara, all of PS- Chandankeyari, Dist- Bokaro, Jharkhand (vi) Pankaj Pal (40 Yrs) S/o- Lt. Naren Pal (vii) Bipin Pal (42 Yrs) S/o- Lt. Ajit Pal & (viii) Babu Gorain (50 yrs) S/O- Lt. Shibu Gorain all of Vill- Nadiara, PS- Purulia (M), Dist- Purulia and 08 (Eight) bicycles loaded with illegal coal in eight gunny bags containing approx 10 (ten) quintal and also taken 01 kg of coal from each bicycle as sample.

I beg to state that on 05.11.2023 at about 09:55 hrs. I received source information that some persons loaded with illegal coal by bicycles in gunny bags are coming to Manguria side under Tamna PS from Nadiara side. After receiving the information, I contacted you and as per your instruction myself along with force left to work out the said information. At about 10.25 hrs while I along with force reached at Sanik School more under Tamna PS found some persons coming towards Sainik School More from Nadiara side with coal loaded by cycle. On seeing the Police party, the above noted alleged persons tried to flee away to leave their bicycles loaded with coal but we managed to apprehend them. On being asked they disclosed their identity as noted above. On demand they failed to produce any valid documents in respect of loaded coal. On preliminary enquiry it could be learnt that the above noted persons along with others, from where the coal has been procured and selling the illegal coal from different places and transporting the same in a clandestine manner. So, it is reasonable to believe that they were transporting the coal illegally after procuring.

Accordingly I seized 08 (eight) bicycles loaded with coal approx 10 (ten) quintal under proper seizure list duly signed by the accompanied Police persons as no local witness showed interest to be witness, as such I could not collect the signature of the local people in seizure list during seizure. I have taken total 08 Kgs of coal, 1 kg from each bicycle as a sample after preparing the proper label.

I also arrested the above noted accused persons after maintaining all the formalities of arrest. Informed them the ground of arrest and issued Memo of Arrest after issuing check lists. The seized articles were taken away at PS after arranging vehicle.

Therefore, I pray before you that a specific case may kindly be registered the alleged persons namely (i) Pasupati Rajwar (60 Yrs) S/O- Lt. Shyamal Rajwar (ii) Kalipada Rajwar (50 yrs) S/o- Lt. Shikdar Rajwar both of Vill- Parbahal, (iii) Ramanath Rajwar (56 Yrs) S/O- Lt. Badi Rajwar of Vill- Gamariya, (iv) Sukdeb Rajwar (42 Yrs) S/o- Lt. Rathu Rajwar (v) Bhagirath Roy (46 yrs) S/O- Lt. Kalchar Roy both of Vill- Ghoragara, all of PS- Chandankeyari, Dist- Bokaro, Jharkhand (vi) Pankaj Pal (40 Yrs) S/o- Lt. Naren Pal (vii) Bipin Pal (42 Yrs) S/o- Lt. Ajit Pal & (viii) Babu Gorain (50 yrs) S/O- Lt. Shibu Gorain all of Vill- Nadiara, PS- Purulia (M), Dist- Purulia under proper section of law.
