Sir.

In producing here with one arrested accused person Rengu Singh (43 Yrs) S/O Lt. Viswa Singh of vill- Kadampur, P.S.-Arsha Dist-Purulia along with following seized articles.

- 1) One white colour plastic container containing approx 18 ltrs. of ID liquor.
- 2) Approx 500 ml ID liquor taken out from of the above container as sample packed with sealing wax and labeled)

I, SI Mrinmay Bhakta of Arsha PS do hereby lodge a typed complaint against the above noted accused person to the effect that today i.e 03.12.2023 at about 16.45 hrs. during my Spl. mobile duty near Aharrah Morh under Arsha PS area, received source information over telephone that the above noted accused has been selling ID liquor at Kadampur morh under Arsha G.P. On receiving the source information, I communicated with O/C Arsha PS over telephone and as per his direction, I along with C/- 1479 Anup Mahata of Arsha P.S and C/- 192 Pintu Sharma of SAP 7th BN camp at Arsha PS, rushed to the spot for work out the information vide Arsha PS Spl. C.C. No. 292/23 dtd- 03.12.2023. Reaching at Kadampur morh at 16.55 hrs, we fixed-up the spot and found that Rengu Singh (43 Yrs) S/O Lt. Viswa Singh of vill- Kadampur, P.S.-Arsha Dist-Purulia was selling of ID Liquor and having seen police all customers managed to escape, but we were able to apprehend the above noted accused person who was selling ID liquor. On demand he failed to produce any valid documents in support of selling ID liquor. So, I seized one white colour plastic container containing approx 18 ltrs. of ID liquor under a proper seizure list from his possession in presence of witnesses, properly sealed and labeled it duly signed by the accused person and witnesses out of which approx 500 ml was taken out from the above container as sample packed with sealing wax and labeled it. During interrogation he confessed his guilt. So, I arrested him after observing all the formalities issuing memo of arrest as he was selling ID liquor illegally.

I therefore, pray that a specific case may kindly be started against the accused person namely Rengu Singh (43 Yrs) S/O Lt. Viswa Singh of vill- Kadampur, P.S.-Arsha Dist-Purulia under proper section of law.
