I, Sukhendu Mudi, S/O-Lt.Mritunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC,WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Jhagru Kumar, S/O-Khokon Kumar of Village – Dhadkidi(near Vill.-Kumardihi), PS-Arsha,Dist-Purulia has committed theft of electricity U/S 135(1)(a) of electricity act 2003 subsequently amendment act 2007.

On 15.12.2023 at about 02:05PM I along with Partha Chakraborty,S/O-Late Dinbandhu Chakraborty,Divisional Engineer(S & LP),Purulia Regional Office,Age-36 Years, Promod Ranjan Barman, Special Officer, S & LP Unit Purulia Regional Office,Age-62 Years and Dayamoy Mahato, Sr. Technical Support Hand, S & LP Unit Purulia Regional Office,Age-31 Years went to routine inspection in Dhadkidi Village(near village kumardihi) and entered the commercial premises of Jhagru Kumar, S/O-Khokon Kumar and found that Jhagru Kumar, S/O- Khokon Kumar was enjoying electricity unauthorisedly by direct hooking of nearby LTOH Line of WBSEDCL and enjoying power in his commercial premises. The hooking connection of Jhagru Kumar, S/O- Khokon Kumar disconnected on the spot from nearby LTOH Line of WBSEDCL on 15.12.2023 at about 02:25 PM. During inspection we found the electrical load he is enjoying as 0.750KW.The inspection team left the premises of the accused person at about 02:30 PM.

Jhagru Kumar, S/O- Khokon Kumar of Village - Dhadkidi(near Vill.-Kumardihi), PS-Arsha,Dist-Purulia has committed an offence U/S 135 (1)(a) electricity act 2003(Amendment Act 2007),so you are requested to take cognizance of this complaint and treat it as FIR.
