Respected Sir,

In producing here with one arrested accused person namely Paban Gorain (50Yrs) S/O Lt. Bhisma Gorain of vill- Kadampur, P.S.-Arsha Dist-Purulia along with following seized articles.


- 1) 02 (two) white colour plastic containers containing total approx 32 ltrs. of ID liquor.
- 2) Approx 01 ltrs ID liquor taken out from each container as sample packed with sealing wax and labeled.(Total 02(Two) ltrs.)

I, SI Mrinmay Bhakta of Arsha PS do hereby lodge a typed complaint against the above noted accused person to the effect that today i.e 24.12.2023 at about 18.05 hrs. during my Spl. mobile duty near Aharrah Morh under Arsha PS area, received source information over telephone that the above noted accused has been selling ID liquor at Kadampur village under Arsha G.P. On receiving the source information, I communicated with O/C Arsha PS over telephone and as per his direction, I along with C/- 361 Sanjay Paramanik and C/- 194 Tarani Gorai of SAP 7th BN camp at Arsha PS, rushed to the spot for work out the information vide Arsha PS GDE No. 997 dtd- 24.12.2023. Reaching at Kadampur village at 18.25 hrs, we fixed-up the dwelling house of Paban Gorain (50Yrs) S/O Lt. Bhisma Gorain of vill- Kadampur, P.S.-Arsha Dist-Purulia and found that Paban Gorain was selling of ID Liquor and having seen police all customers managed to escape. But we were able to apprehend the above noted accused person namely Paban Gorain (50Yrs) S/O Lt. Bhisma Gorain of vill- Kadampur, P.S.-Arsha Dist-Purulia, who was selling ID liquor. On demand he failed to produce any valid documents in support of selling ID liquor. So, I seized 02 (two) white colour plastic containers containing total approx 32 ltrs. of ID liquor under a proper seizure list from his possession in presence of witnesses and properly sealed and labeled which was duly signed by the accused person and witnesses. From the major contraband approx 01 ltrs was taken out from each containers as sample (Total 2 ltrs) and packed with sealing wax and labeled it. During interrogation he confessed his guilt. So, I arrested him after observing all the formalities and issued memo of arrest as he was selling ID liquor illegally.

I therefore, pray that a specific case may kindly be started against the accused person namely Paban Gorain (50Yrs) S/O Lt. Bhisma Gorain of vill- Kadampur, P.S.-Arsha Dist-Purulia under proper section of law.
