Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 (1)/(b) & (1)/(d) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 14/12/2023 at 15:10 Hrs. I, Sisir Kumar Das (DE & SM Bagmundih CCC), S/O Banamali Das along with Chanchal Mondal [DE(E), Purulia Region office] , Sushanta Baul [JE(C) , Purulia Region], Anup Mondal [JR. Engineer (E), Gr. I] and Subhasis Mahato (Sr. O.E.) went to make an inspection to workout upon a source information regarding theft of electricity at the domestic premises of user Basudeb Mahato, son of Lt Thakur Das Mahato, resident of Vill - Torang, PO- Dava-Torang, PS- Bagmundi , Dist Purulia .

During the time of inspection at the premises 1 no of electricity meter were found having serial no DDG256048 (Consumer id 242102150, User Name- Basudeb Mahato).

It was observed that accused Basudeb Mahato has made unauthorized use of electricity under section 135 1/b & 1/d by tampering the meter circuit of meter serial no DDG256048 hence causing huge loss of revenue to WBSedcl. From the above arrangement the accused was using 0.75 KW load.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected both the service lines in the same premises from pole with the help of LT Mobile Van Team and removed & seized 1 nos of damaged energy meter bearing meter no DDG256048. Prepared seizure list and inspection report. Accused refused to sign the seizure and inspection documents.

The inspection team left the premises at about 15:30 Hrs on 14<sup>th</sup> Dec 2023.

The accused committed theft of electricity U/S 135 (1)/(b) & (1)/(d) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
