In producing herewith two accused persons namely 1) Birbal Mahato (50 yrs) S/O-Late Nagen Mahato of Village- Nekre, P.S- Balarampur, Dist- Purulia, WB & 2) Tapan Mahato (35 Yrs) S/O - Jogendra Mahato of Village- Chandrapur, P.O-Madhupur, P.S- Saraikella, Dist-Saraikella Kharswan, Jharkhand along with two (02) seized Motorcycles and one aadhar card as per seizure list. I Goutam Kr. Mahata of Balarampur P.S beg to state that today i.e on 17.12.2023 at about 16:05 hrs received a tip of information that one Tapan Mahato came to the house of Birbal Mahato S/O- Late Nagen Mahato of Vill- Nekre, P.S- Balarampur, Dist- Purulia with two stolen motorcycles for selling/dispose off. I informed the matter to my O/C, Balarampur PS and as per his kind direction myself along with force 1) C/2675 Pintu Mandal 2) C/2356 Arjun Yadav, 3) C/2484 Amit Kr. Ghorai, 4) C/2531 Avhisekh Mahanty 5) C/1478 Dhirendra Nath Mahato, 6) C/1412 Sushanta Patra (vide Balarampur GDE No- 893 date- 17.12.2023) left PS to work out the information. After arriving (at about 16:45 hrs) at the house of Birbal Mahato of Nekre village, I detain the above noted two persons and interrogated very carefully and found two motorcycles without its number plate have been kept in the house premises of Birbal Mahato. I asked to provide the valid paper in respect of the said Motorcycles but no sooner I had asked for the papers than they started stammering that led to suspicious. Further, I asked for the papers regarding ownership but neither could they provide any proper valid document related to the motorcycles nor could give any satisfactory reply pertinent to the Motorcycles. During interrogation the above noted two persons namely Birbal Mahato & Tapan Mahato confessed that the motorcycles having its 1) Engine No- HA10ERGHH14719 & Chassis No- MBLHA10CGGHH04634 (Hero Splendor Plus, black & blue colour) 2) Engine No-HA10ERFHJ41631 & Chassis No-MBLHA10BFFHJ39319 (Hero Splendor Pro, Grey & Red colour) are the stolen motorcycles which aiming to purpose of selling. On further interrogation, they confessed that they (accused) have stolen that bikes & taken it to Balarampur PS area for selling as they used to do it with them habitually dealing in stolen property (motorcycle) since last few years.

Accordingly I seized the aforesaid Motorcycles having its 1) Engine No-HA10ERGHH14719 & Chassis No- MBLHA10CGGHH04634 (Hero Splendor Plus, black & blue colour) 2) Engine No-HA10ERFHJ41631 & Chassis No- MBLHA10BFFHJ39319 (Hero Splendor Pro, Grey & Red colour) & one Aadhar card of Tapan Mahato vide Aadhar No-833143706249 under proper seizure list duly signed by accused persons & accompanied Police Personnel and arrested the accused persons 1) Birbal Mahato (50 yrs) S/O-Lt. Nagen Mahato, of Vill- Nekre, P.S- Balarampur, Dist- Purulia, WB 2) Tapan Mahato (35 Yrs) S/O-Jogendra Mahato of Vill- Chandrapur, P.O-Madhupur, P.S-Saraikella, Dist-Saraikella Kharswan, Jharkhand under proper formalities.

The aforesaid two accused persons also stated that they have accumulated more stolen motorcycles for purpose of habitually dealing in stolen motorcycle by theft since last few years So I brought them (accused Birbal Mahato & Tapan Mahato) with seized articles at Balarampur PS.

Therefore, I pray that a specific case may kindly be registered against the following persons namely 1) Birbal Mahato (50 yrs) S/O-Lt. Nagen Mahato, of Vill-Nekre, P.S- Balarampur, Dist- Purulia, WB 2) Tapan Mahato (35 Yrs) S/O-Jogendra Mahato of Vill- Chandrapur, P.O-Madhupur, P.S- Saraikella, Dist-Saraikella Kharswan, Jharkhand U/S-379/411/413/414 IPC.
