Sub: Complaint against Gurupada Mahato (48 yrs) S/O-Lt. Kunja Mahato of Vill- Ruchap Tola Kendradih, P.S- Balarampur, Dist- Purulia to start a specific case U/S 46A(c) B.E. Act. of 1909.

Respected Sir,

In producing here with one arrested accused person namely Gurupada Mahato (48 yrs) S/O-Lt. Kunja Mahato of Vill- Ruchap Tola Kendradih, P.S- Balarampur, Dist- Purulia along with seized 1) 10 bottle country sprit style as 'DIL SE' each bottle containing 600 ml (MRF each Rs-55/-) & 2) One plastic jarican containing approx 08 litters ID liquor (details of seized articles are mentioned in attached seizure list), to the effect that today on 30.11.2023 I SI Pratap ch. Ojha along with C/1478 Dhirendranath Mahato & C/1002 Somlal Murmu (SAP 11th Bn.) was engaged in evening mobile duty vide Balarampur PS CC No-5079/2023 dt-30.11.2023. In course of mobile duty at about 20:05 hrs, I received a telephonic information from a reliable source that t one person have stocked some illicit liquor at his own house at Ruchap Tola Kendradih under Balarampur P.S. selling the same to innocent people for his personal gain. Accordingly, I informed to O/C Balarampur P.S. regarding this matter and as per his direction I along with force left for Ruchap Tola Kendradih village to work out this information. Thereafter as per source at 20:25 hrs we reached at Ruchap Tola Kendradih village, I along with force held raid in the dwelling house of Gurupada Mahato.

During search with the help of accompany with force, we found that the said person is selling ID liquor at his respective house at Ruchap Tola Kendradih village. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said ID liquor. Accordingly, I seized the following articles from the possession of accused person as follows- 1) 10 bottle country sprit style as 'DIL SE' each bottle containing 600 ml (MRF each Rs-55/-) 2) One plastic jarican containing approx 08 litters ID liquor & one plastic bottle ID liquor (600 ML approx) as a sample out of 08 ltrs. (after preparing proper seizure list duly signed by the witnesses and labelled. I arrested him after preparing proper arrest memo as he committed offence U/S 46A(c) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(c) B.E. Act against the arrested accused person namely Gurupada Mahato (48 yrs) S/O-Lt. Kunja Mahato of Vill- Ruchap Tola Kendradih, P.S- Balarampur, Dist- Purulia to start a cog case U/S 46A(c) B.E. Act and arrange for its investigation.
