I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Rupchand Gorai, S/o – Nagen Gorai, Vill-Haludboni, PS – Bandwan, Dist – Purulia has committed theft of electricity U/S 135/1/a of The Electricity Act.

On 12/12/2023 about 01:40 pm, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL, along with, Raghunath Saren, Office Executive, Bundwan CCC, WBSEDCL visited the premises of Rupchand Gorai, S/o – Nagen Gorai, Vill-Haludboni, PS – Bandwan, Dist – Purulia and inspect his premises. During inspection theft of electricity was detected i.e. he was using electricity dishonestly by means of DIRECT HOOKING from nearest SMC Box.

From the above arrangement he was using the following electrical equipment's:

- 1) Tube light – 1 Nos
- 2) Bulb – 1 Nos
- 3) Pump – 1 Nos

Out of which I seized the following:

- 1) Service wire (90 mtr approx).

Seizure list was prepared at the site and accused person signed.

The inspection team left the premises at 02:05 pm on 12/12/2023.

The accused person has committed an offence U/S 135/1/a of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
