I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Pintu Karmakar, S/o – Surja Karmakar, Vill- Harada, Kumar Para, PS – Bandwan, Dist – Purulia has committed theft of electricity U/S 135/1/a of The Electricity Act.

On 18/12/2023 about 02:10 pm, I, Prashanta Mandal, AE&SM, Bandwan CCC, WBSEDCL, along with, Anindya Sundar Paul, Office Executive, Bandwan CCC, WBSEDCL and Shubhankar Majumdar, Sr-TSH visited the premises of Pintu Karmakar, S/o – Surja Karmakar, Vill- Harada, Kumar Para, PS – Bandwan, Dist – Purulia and inspect his premises. During inspection theft of electricity was detected i.e. he was using electricity dishonestly by means of DIRECT HOOKING from nearest LTOH line.

From the above arrangement he was using the following electrical equipment's:

- 1) Bulb – 3 Nos

Out of which I seized the following:

- 1) Flexible wire (8 mtr approx).

Seizure list was prepared at the site and accused person refused to sign.

The inspection team left the premises at 02:45 pm on 18/12/2023.

The accused person has committed an offence U/S 135/1/a of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
