I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Satrughna Sing, S/o – Late Chaitan Sing, Vill- Katagora, PS – Bandwan, Dist – Purulia. has committed theft of electricity U/S 135/1/a of The Electricity Act.

On 18/12/2023 about 03:25 pm, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSIEDCL, along with, Anindya Sundar Paul, Office Executive, Bundwan CCC, WBSIEDCL and Shubhankar Majumdar, Sr-TSH visited the premises of Satrughna Sing, S/o – Late Chaitan Sing, Vill- Katagora, PS – Bandwan, Dist – Purulia and inspect his premises. During inspection theft of electricity was detected i.e. he was using electricity dishonestly by means of DIRECT HOOKING from LTOH line.

From the above arrangement he was using the following electrical equipment's:

- 1) Bulb – 2 Nos
- 2) Fan – 1 Nos

Out of which I seized the following:

- 1) Flexible wire (8 mtr approx).

Seizure list was prepared at the site and accused person signed.

The inspection team left the premises at 03:50 pm on 18/12/2023.

The accused person has committed an offence U/S 135/1/a of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
