Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that MANOJ KUMAR KATARUKA S/O BINOD KATARUKA -Vill- BARABAZAR JAYNAGARPARA, Dist- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (Sl No- GE0534028) From its incoming Service Cable through 02-Core PVC wire and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

On 19.12.2023, I Sri Banti Karmakar, A.E. & S.M, BARABAZAR CCC, WBSEDCL along with

- (1) Abhisek Singh, D.E, WBSEDCL
- (2) Ashutosh Sharma, JE (E) - I WBSEDCL
- (3) Shibaji Chakraborty, J.E GR II. BARABAZAR CCC, WBSEDCL
- (4) Mandeep Chakladar, O.E, BARABAZAR CCC, WBSEDCL
- (5) Along with LT team

At About 02:25 P.M., entered into the premises of MANOJ KUMAR KATARUKA S/O BINOD KATARUKA -Vill- BARABAZAR JAYNAGARPARA, Dist- Purulia and inspected his premises.

While having inspection at the premises of MANOJKUMAR KATARUKA S/O BINOD KATARUKA of Barabazar in presence of consumer representative Binod Kataruka, it was found that the accused was using electricity by means of bypassing the meter consumption with cutting the service cable having specification of aluminum 2 core 4 square mm and joining an extra cable having specification with 2 no. of copper 2.5 stranded red in color cable used for giving power to an adjacent electrically connected domestic premises having consumer ID: 242044245 along with this own commercial premises, in his premises at BARABAZAR JAYNAGARPARA having connected load 02.17 KVA.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 02:40 P.M.

The said person has committed an offence U/S 135(1)/(b) of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
