Sub :F.I.R. against Unauthorized use of Electricity against ASIM KUMAR MAHANTY S/O Lt.SIBAPRASAD MAHANTY -Vill- SIMULDANGA, having consumer ID- 242174890 and meter No.- G02742991, P.S- Barabazar , Dist- Purulia, U/S 135(1)/(b) of the electricity (Amendment act-2007)

Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act-2007, to the effect that ASIM KUMAR MAHANTY S/O Lt.SIBAPRASAD MAHANTY -Vill- SIMULDANGA, Dist- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- G02742991) From its incoming Service Cable through 02-Core PVC wire and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

On 27.12.2023, I Sri Banti Karmakar, A.E.&S.M, BARABAZAR CCC, WBSEDCL along with

- (1) Shibaji Chakraborty, J.E GR II, BARABAZAR CCC, WBSEDCL
- (2) Suresh Sao, O E, BARABAZAR CCC, WBSEDCL
- (3) Along with LT team

At About 12:15 P.M., entered into the premises of ASIM KUMAR MAHANTY S/O Lt.SIBAPRASAD MAHANTY -Vill- SIMULDANGA, Dist- Purulia and inspected his premises.

While having inspection at the premises of ASIM KUMAR MAHANTY S/O Lt.SIBAPRASAD MAHANTY of Barabazar in presence of his wife Mamoni Mahanty, it was found that the accused was using electricity by means of bypassing the meter consumption with cutting the service cable having specification of aluminum 2 core 4 square mm and joining an extra copper 4sq mm cable blue in colour for giving power to his own domestic premises at Vill- SIMULDANGA having connected load 0.588 KVA.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 12:30 P.M.

The said person has committed an offence U/S 135(1)/(b) of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
