Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that RADHA RAMAN PANDEY S/O LATE KARTIK PANDEY -Vill- NISCHENTAPUR, Dist- Purulia was enjoying electricity illegally by by-passing the Single Phase Energy Meter (SI No- **B3891712**) From its incoming Service Cable through 02-Core PVC wire and he has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

On 27.12.2023, I Sri Banti Karmakar, A.E & S.M, BARABAZAR CCC, WBSEDCL along with

- (1) Shibaji Chakraborty, J.E GR II, BARABAZAR CCC, WBSEDCL
- (2) Suresh Sao, O E, BARABAZAR CCC, WBSEDCL
- (3) Along with LT team

At About 1:10 P.M., entered into the premises of RADHA RAMAN PANDEY S/O LATE KARTIK PANDEY -Vill- NISCHENTAPUR, Dist- Purulia and inspected his premises.

While having inspection at the premises of RADHA RAMAN PANDEY S/O LATE KARTIK PANDEY of Barabazar in presence of his son Tilak Pandey, it was found that the accused was using electricity by means of bypassing the meter consumption with cutting the service cable having specification of aluminum 2 core 6 square mm and jointing an extra cable having specification 2 core 6 sq mm Aluminum cable, in his premises at Vill- NISCHINTAPUR having connected load 1.5 KVA.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 1:25 P.M.


The said person has committed an offence U/S 135(1)/(b) of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.





