I do hereby lodge complaint empowered by enabling The Indian Electricity Act – 2003, subsequently Electricity (Amendment) Act 2007 to the effect that Prabodh Chandra Paul, S/o - Kista Paul, Vill-Chhotokadam, PS – Boro, Dist – Purulia has committed theft of electricity U/S 135/1/a of The Electricity Act.

On 12/12/2023 about 11:58 am, I, Prashanta Mandal, AE&SM, Bundwan CCC, WBSEDCL, along with, Raghunath Saren, Office Executive, Bundwan CCC, WBSEDCL visited the premises of Prabodh Chandra Paul, S/o - Kista Paul, Vill-Chhotokadam, PS – Boro, Dist – Purulia and inspect his premises. During inspection theft of electricity was detected i.e. he was using electricity dishonestly by means of DIRECT HOOKING from nearest LTOH line.

From the above arrangement he was using the following electrical equipment's:

- 1) Refrigerator – 1 Nos, 2) AC – 1 Nos, 3) Pump – 1 Nos, 4) FAN – 4 Nos, 5) Induction Stoves – 1 Nos, 6) Bulb – 9 Nos, 7) TV – 1 Nos

Out of which I seized the following:

- 1) Flexible wire mixed of Black & Yellow (9 mtr approx).

Seizure list was prepared at the site and accused person refused signed.

The inspection team left the premises at 12:25 pm on 12/12/2023.

The accused person has committed an offence U/S 135/1/a of The Electricity Act – 2003 & subsequently Electricity (Amendment) Act – 2007.

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
