Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Bimala Kanta Mahato, S/o- Manohar Mahato, of Village- Kheriadih, P.O- Dhabani, P.S.- Boro, Dist - Purulia, has committed unauthorise supply of Electricity to a disconnected premise U/S 135(1)(e) of the Electricity (Amendment) Act-2007.

On dated 20.12.2023, at about 02:40 PM, I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with, Sri Chanchal Mandal, D.E(Electrical), Purulia Regional Office, Sri Sushanta Baul, J.E( Electrical), Purulia Regional Office & Sri Sourav Mukherjee, Senior TSH, Manbazar CCC entered the premise of Bimala Kanta Mahato, S/o- Manohar Mahato of Village- Kheriadih, P.O- Dhabani, P.S.- Boro, Dist – Purulia and inspected his premise and found that he was supplying electricity to the disconnected premise of Naba Kumar Mahato(Consumer id-242118667) unauthorisely.

During inspection, it was found that he was supplying electricity dishonestly U/S 135(1)(e) was detected. A flexible wire of length about 03 (three) meter is seized.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 02:55 P.M on dated 20.12.2023. The accused person has committed an offence U/S 135(1)(e) of the Electricity (Amendment) Act-2007.

The service connection has been disconnected on 20.12.2023. You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
