Respected Sir,

I Shila Mukherjee yesterday 17 Dec 2023 talking with my daughter at my home regarding the garbages at my wall suddenly Heera Mukherjee and her husband Heera Lal Mukherjee, ^{S/O Late Nabin Ranjan Mukherjee from Ladhuma village.} abusing my Daughter and assassinated her character like all the time. My daughter said, you are abusing why? and you are using this place you should keep it clean till the moment Heera Lal Mukherjee threw Bricks and a large dustbin at my daughter, and started hitting her badly by pulling her hair, slapping her and push her badly from the wall then my husband and I Shila and Subodh Mukherjee went to protect her then Heera Lal Mukherjee bit my husband Subodh Mukherjee and hit me with Bricks, and throw Bricks at me too. After sometime we called 100

number at emergency till the time police will

arrive they all entered into my house forcefully and hit my daughter with stick. Heera Lal Mukherjee, Gopa Banerjee, Suman Mukherjee, Aparna Mukherjee, Meera Mukherjee, Teisha Banerjee they all forcefully break the main door and try to enter my house with Iron rod, Bamboo rod and tried to kill us. My husband has health issues and I have single girl child how we will survive like this we feel threatened.

Apart from that Gopa Banerjee, Heera Lal Mukherjee, Aparna Mukherjee, Suman Mukherjee continuously used filthy words for my daughter in front of society. My girl is unmarried and a respectful girl they try to infringe to "Line with Dignity".

They are continuously torcheing 3 of us by calling my husband mentally ill, before also they have given Rape threat because of that my daughter already gave a complaint. We are seriously want a strict and legal action against them.

With all these they hit so hard my girl couldn't move her spinal cord or bend down. I also got injury and we had to rush to the hospital at Hura at night only.

We are in fear that Gopa Banerjee, Sunan Mukherjee, Aparna Mukherjee, Heera Lal Mukherjee can kill us like this.

They are continuously torcheing us mentally, Emotionally, Physically from many years.

So, sir we request Police to take strict and legal Action Against them.
