

And by supplying electricity to the premises of **Sri Shraban Mandal, Sri Gagan Ch Mandal** has committed theft of electricity u/s 135 (1) (e) of the Electricity (Amendment) Act-2007.


On dated **19.12.2023** at around **10:15 AM** myself Shri. Shyamsunder Murmu, D.E.(E) & Station Manager of Hura CCC along with Shri Biswajit Pal, J.E. (E) Gr.II and Shri. Bhudeb Ch Mahato, Sr. TSH both posted at Hura CCC, WBSEDCL has entered the premises of **Sri. Gagan Ch Mandal, S/o: Sri Ajit Mandal** and inspected his premises. During inspection theft of electricity was detected u/s 135 (1) (e) i.e., he was enjoying electricity other than the purpose for which it was supplied..

After that the inspection team left the premises at around **10:30 AM** on **19.12.2023**.

You are requested to take cognizance of this complaint and treat it as FIR and action may be taken against the accused as per rules.
