Dear Sir,

I do hereby lodge complaint empowered by enabling the Electricity Act-2003, Subsequently Electricity (Amendment) Act-2007 to the effect that **Sri. Lalmohan Mudi** (Current User) was enjoying Electricity un-authorizedly by reconnecting energy meter of Smt. Sishubala Mudi (Mother of Lalmohan Mudi) vide Meter No: **BR723778** Consumer Id: **202395596** of W.B.S.E.D.C.L.

On dated **28.02.2019** the meter was disconnected due to non-payment of Electricity Energy bill. And by reconnecting on his own **Sri Lalmohan Mudi** has committed theft of electricity u/s 138 (1) (a) & 138 (1) (b) of the Electricity (Amendment) Act-2007.

On dated **19.12.2023** at around **11:40 AM** myself Shri. Shyamsunder Murmu, D.E.(E) & Station Manager of Hura CCC along with Shri Biswajit Pal, J.E. (E) Gr.II and Shri. Bhudeb Ch Mahato, Sr. TSH both posted at Hura CCC, WBSEDCL has entered the premises of **Sri. Lalmohan Mudi, S/o: Yudhisthir Mudi** and inspected his premises. During inspection theft of electricity was detected u/s 138 (1) (a) & 138 (1) (b) i.e., he was using electricity by un-authorizedly reconnecting the energy meter which was disconnected by the office for non-payment of Electricity Energy Bill.

After that the inspection team left the premises at around **11:55 AM** on **19.12.2023**.

You are requested to take cognizance of this complaint and treat it as FIR and action may be taken against the accused as per rules.
