I do hereby lodge complaint empowered by enabling the Electricity Act-2003, Subsequently Electricity (Amendment) Act-2007 to the effect that **Sri. Kabul Ch Mandal** was enjoying Electricity un-authorizedly by Hooking from nearest LTOH line.

On dated **19.12.2023** at around **12:55 PM** myself Shri. Shyamsunder Murmu, D.E.(E) & Station Manager of Hura CCC along with Shri Biswajit Pal, J.E. (E) Gr.II and Shri. Bhudeb Ch Mahato, Sr. TSH both posted at Hura CCC, WBSEDCL has entered the premises of **Sri. Kabul Ch Mandal S/o: Late Ajit Prasad Mandal** and inspected his premises. During inspection theft of electricity was detected u/s 135. i.e., he was using electricity dishonestly by drawing illegal hooking from the nearest LTOH line of WBSEDCL.

From the above arrangement he was using the following electrical equipments:-

1. LED Bulb = 05 Nos
2. Ceiling Fan = 03 Nos

Out of which I seized the following

1. Flexible Wire = 16 feet (Approx.)

After that the inspection team left the premises at around **1:05 PM** on **19.12.2023**.
