Sir,

This is to inform you that the office of the undersigned have conducted a joint raid along with the officials of your office on 20/12/2023 around 05.00 A.M near Amrachocha ghat of Kasai River Nischintapur ,etc. area under Hura. During raid two tractors bearing model no. 265DI MKM DLX(Mahindra), chassis no.- MBNABACAAMRJ 09550 , engine no- RMJ2BBN 1784 and model no. B275DI TU MKM DLX(Mahindra), chassis no.-MBNABAEXPJRH 06007, engine no- RJH2EAN 5847 loaded with sand (Approx, 100 c.ft) found near Nischintapur area without valid challan. The said tractors were detained at the spot. Before the detainment of the tractors, both the drivers of the said tractors have run away by unloading the tractors from the place of occurrence. As there was no one present at the spot and the drivers of the said tractors fled away from the spot, therefore took the two unloaded tractors bearing model no. 265DI MKM DLX(Mahindra), chassis no.- MBNABACAAMRJ 09550 , engine no- RMJ2BBN 1784 and model no. B275DI TU MKM DLX(Mahindra), chassis no.-MBNABAEXPJRH 06007, engine no- RJH2EAN 5847 along with us . The said unloaded tractors have been handed over to your good for further course of action.

Therefore, the undersigned is requesting you to treat this complain as FIR and to take necessary action as per the provision of Sec 21 of MMDR ACT and the rule framed there under against drivers and owners of the said tractors.
