I do hereby lodge complaint empowered by enabling the Electricity Act-2003, Subsequently Electricity (Amendment) Act-2007 to the effect that **Jabbar Ansary** was enjoying Electricity un-authorizedly by Hooking from nearest LTOH line.

On dated **22.12.2023** at around **10:40 AM** myself Shri. Shyamsunder Murmu, (39/M) D.E.(E) & Station Manager of Hura CCC along with Shri Biswajit Pal, (27/M) J.E. (E) Gr.II and Shri. Dharapati Mahato, (42/M) Sr. TSH both posted at Hura CCC, WBSEDCL has entered the premises of **Jabbar Ansary S/o: Sukur Ansary** and inspected his premises. During inspection theft of electricity was detected u/s 135. i.e., he was using electricity dishonestly by drawing illegal hooking from the nearest LTOH line of WBSEDCL.

From the above arrangement he was using the following electrical equipments:-

1. LED Bulb = 05 Nos
2. Ceiling Fan = 03 Nos

Out of which I seized the following

1. Flexible Wire = 8 feet (Approx.)

After that the inspection team left the premises at around **10:55 AM** on **22.12.2023**.

You are requested to take cognizance of this complaint and treat it as FIR and action may be taken against the accused as per rules.
