Sir,

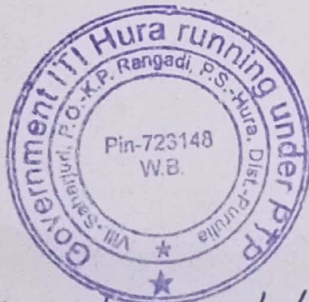
With reference to the subject cited above the undersigned wish to inform you the following few facts.
