


Sir,

In producing here with one arrested accused person namely (i) Ajoy Chandra (38) S/O Lt. Paritosh Chandra of Jhalda Poddar Para, Ward No-8, PS-Jhalda, Dist-Purulia and (ii) Rabi Rajwar (25) S/O Mihir Rajwar of Jhalda Dom Para, Ward No-8, PS-Jhalda, Dist-Purulia and brought under seizure of the following articles i.e. (i) 35 (Thirty-five) Pcs sealed bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup as ONEREEX @ Rs. 159.50/- per bottle, having 100 ml in each bottle, (ii) 03 Pkts of Alprazolam Tablets I.P. 0.5 mg as ALPHA 0.5 tablets having 10 x 6 x 10 tablets in each pkt. (iii) One White colour bag and (iv) One Motor Cycle having Reg. No. JH05BD/8854 from the exclusive possession of the accused persons mentioned above. I, SI Aloke Chattaraj of Jhalda PS do here by lodged a written complaint against (i) Ajoy Chandra (38) S/O Lt. Paritosh Chandra of Jhalda Poddar Para, Ward No-8, PS- Jhalda, Dist- Purulia and (ii) Rabi Rajwar (25) S/O Mihir Rajwar of Jhalda Dom Para, Ward No-8, PS- Jhalda, Dist- Purulia to the effect that today (09/12/2023) while performing evening mobile duty (This refers to Jhalda P.S. GDE No- 514 Dt- 09/12/2023 and vide C.C. No- 3689 Dt- 09/12/2023) near Mosina more, I received an information from my source at about 20:05 hrs that 02 (two) persons, namely Ajoy Chandra & Rabi Rajwar are coming towards Jhalda Town carrying huge quantity of Cough Syrup in a white colour bag for selling clandestinely to the youth customers of Jhalda town area. After receiving this information I immediately informed to you and the duty officer for noting down the information. Subsequently, as per your gracious direction, I, SI Aloke Chattaraj along with (i) C/214-Siddhartha Mandal, (ii) NVF/778 Samir Ch. Mahato and (iii) HG/1827 Sahadeb Singha all of Jhalda PS left Mosina more immediately to work out the information. We, all reached with Govt. Vehicle near Kansra more at 20:25 Hrs and found 02 (two) persons are going towards Jhalda Town from Jharkhand side with a White colour bag in a Motor Cycle having Reg. No. JH05BD/8854 as identical as I received information. Subsequently, I apprehended them near Kansra more under this PS and searched and found that they are carrying huge quantity of Cough Syrup in a White colour bag. On its counting it is found as (i) 35 (Thirty-five) Pcs sealed bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup as ONEREEX @ Rs. 159.50/- per bottle, having 100 ml in each bottle, (ii) 03 Pkts of Alprazolam Tablets I.P. 0.5 mg as ALPHA 0.5 tablets having 10 x 6 x 10 tablets in each pkt. On interrogation they disclosed their identity as mentioned above and they also said that they collected these illegal cough syrup from Ramgarh under Jharkhand state. On demand they failed to produce any valid documents/license in respect of keeping huge quantity of illegal Drugs. So I seized (i) 35 (Thirty-five) Pcs sealed bottles of Chlorpheniramine Maleate & Codeine Phosphate Syrup as ONEREEX @ Rs. 159.50/- per bottle, having 100 ml in each bottle, (ii) 03 Pkts of Alprazolam Tablets I.P. 0.5 mg as ALPHA 0.5 tablets having 10 x 6 x 10 tablets in each pkt. (iii) One White colour bag and (iv) One Motor Cycle having Reg. No. JH05BD/8854 under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and as well as signed by the apprehended persons and also prepared label with seal and taken sample as (i) 01 (one) bottle of cough syrup ONEREEX and (ii) One strip of ALPHA 0.5 tablets. On interrogation they confessed that they were running Cough Syrup (illegal drugs) business and they were carrying the said syrup and tablets for the purpose of selling to the local youth customers. Subsequently, I arrested them for violating the Sec-27 of Drugs & Cosmetics Act-1940 after maintaining all the formalities regarding arrest and all the guide line of Hon'ble Supreme Court and NHRC.

I, therefore pray before you to start a case against the accused persons namely (i) Ajoy Chandra (38) S/O Lt. Paritosh Chandra of Jhalda Poddar Para, Ward No-8, PS- Jhalda, Dist- Purulia and (ii) Rabi Rajwar (25) S/O Mihir Rajwar of Jhalda Dom Para, Ward No-8, PS- Jhalda, Dist- Purulia U/S 27 of Drugs & Cosmetics Act-1940 and arrange for its investigation.
