

 That the Complainant is the son of one Shyamapada Sen who is a Retired School Teacher and is a Senior Citizen.












- 2. That the Complainant though he is a resident of Jhalda but in course of his avocation has been staying at Delhi along with his old aged father.
- That Shyamapada Sen have executed a Deed of Gift in favor of the Complainant in respect of the Properties of Mouza- Jhalda covered by Holding no. 85 dated 31/03/2006.
- 4. That Accused nos. 1 and 2 are the sons of one Shital Prasad Sen(since deceased) who was the elder brother of Shyamapada Sen.
- 5. That Shital Prasad Sen father of Accused nos. 1 and 2 during his lifetime has filed a Title Suit being no. 45/1994 in the Court of the Ld. Civil Judge (Senior Division), Purulia, against his younger brother Shyamapada Sen and others. The Suit having proceeded to some extent when Shital Prasad Sen found that there was no chance of success he requested his brother Shyamapada Sen to compromise the Suit. Shyamapada Sen used to pay respect to his elder brother and ultimately entered into a compromise in the aforesaid Suit. In the said compromise Holding no. 85 within Ward no. 2 having an area of 1.4875 acres was exclusively allotted to the share of Shyamapada Sen. The said Holding no. 85 consists of R.S Plot nos. 7659, 7660 and 7661.
- 6. That the Suit was disposed of on the basis of compromise.
- 7. That after compromise Shyamapada Sen sold R.S Plot no. 7712 to one Joy Kumar Bhagat. *
- 8. That Accused nos. 1 and 2 were/are fully aware and acquainted about the terms and conditions of the compromise and are fully aware that Northern portion of Holding no. 85 measures an area of 1.4875 acres was/is the exclusive Property of their uncle Shyamapada Sen.
- 9. That Accused nos. 1 and 2 are very influential, muscle and moneyed men. The said Accused nos. 1 and 2 taking advantage that as Shyamapada Babu and his son i.e. the present Complainant are staying at Delhi which is far away from Purulia with a view to injure the interest of the Complainant have executed a General Power of Attorney in favor of Accused nos. 3 and 4 on 22/05/2023 in respect of the Plots aforesaid which were exclusively allotted to the share of Shyamapada Babu. Accused nos. 3 to 5 were conversant with the Compromise Decree passed in Title Suit no. 45/1994.
- 10. That Accused nos. 3 and 4 on the strength of illegal and malafide Power of Attorney executed a Sale Deed in respect of the aforesaid Plot in favor of Accused no. 5 on 26/05/2023 being Deed no. 1899 registered before Additional District Sub-Registrar, Jhalda, in respect of R.S Plot no. 7661 appertaining to R.S Khatian no. 3567 and received a fabulous amount. It may be mentioned here that the aforesaid Plot being no. 7661 was/is the exclusive Property of Shyamapada Sen and at present of the present Complainant.
- 11. That the Accused Persons have hatched a conspiracy with a view to cheat or defraud or deceived the present Complainant.





- 12. That the Accused Persons knowing it fully well that they have no right over R.S Plot no. 7661 but in order to make wrongful loss and created mental tension and agony not only upon the Complainant but also upon the old aged father of the Complainant and have created such fictitious Deed and the intention of the Accused persons was to defame the Complainant and his father before the Society.
- 13. That Accused nos. 3 to 5 in collusion and concert with Accused nos. 1 and 2 created disturbance.
- 14. That the Complainant on 28/03/2023 lodged a Complaint before Inspector-In-Charge, Jhalda Police Station but the Police attached to Jhalda Police Station gave a deaf hear to the genuine grievance of the Complainant. So the Complainant under compelling circumstances lodged a Diary before the Superintendent of Police, Purulia, on 26/06/2023.
- 15. That the Complainant is the only offspring of his father and Shyamapada Babu has been suffering from old aged diseases and the Complainant is badly engaged in his official work for which he could not get any opportunity to come down at Purulia to pursue the matter.
- 16. That the Accused Persons furthermore are still giving out threats to the Complainant and his father through other agencies and the safety and security of the Complainant is at stake.
- 17. That several documents are required to be looked into and search and seizure are involved and furthermore the Complainant is not in a position to prosecute the case personally for which the Complainant files this Application under Section 156(3) of C.R.P.C.
- 18. That the Accused Persons by making a conspiracy have cheated and deceived the Complainant.
- 19. That as Jhalda Police Station in spite of getting specific information/ complaint from the Complainant has not instituted any F.I.R, so let this complaint be forwarded to Inspector-In-Charge, Jhalda Police Station for treating the same as F.I.R and for undertaking investigation.

Hence it is prayed that Your Honour may graciously be pleased to pass appropriate Orders U/S- 156(3) C.R.P.C by directing the Inspector-In-Charge/Officer-In-Charge, Jhalda Police Station to treat the complaint as F.I.R and undertake proper investigation.

Pass necessary Orders for the Interest of Justice.
