Entered the premises of DOYAL CHANDRA, S/o- LT. BAIDYANATH CHANDRA, resident at JHALDA DOMPARA, PS- JHALDA, Dist- PURULIA. having consumer Id- 242009138, Meter no L1478210 and inspected his/ her premises. During the inspection theft of electricity was detected i.e. service cable tapping i.e. U/S 135(I)/(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

2. Color T.V- 01 no.
3. Electric Fan - 01 no.
4. Toto- 01 no.

Out of which I seized the following.

1. Two core service cable approx length 02 feet's along with bypassing arrangement.
