During the inspection theft of electricity was detected i.e. he was using electricity dishonestly by drawing illegal hooking from the nearest LTOH line of WBSEDCL i.e. U/S 135(1/a) was detected.

Out of which I seized the following.

1. PVC two core cable fitted with hooking device approx length 11 feet's along with one bulb.

The accused person has committed an offence U/S 135(1)(a) of the electricity act-2003 & subsequently electricity (Amendment) act-2007.
