Sir,

I, ASI- Tapan Kr. Mahato along with force returned to PS with 01 (one) arrested accd. person namely Hakim Ansari (43) S/O Shoeb Ansari of vill- Jamsingh, PO-Ichahatu, PS-Rajrappa, Dist-Ramgarh, JKD along with seized articles i.e. one Hero Splendor Plus Motorcycle having Reg. No.- BR14H/8731 & Chassis No. MBLHA10AMDHJ75072 loaded with approx 02 Quintal of steam coal under proper seizure list and produced before your good self.

The fact in brief is that today (25/12/2023) myself along with force namely NVF/933 Abani Kumar and NVF/778 Samir Ch. Mahato were performing Spl. evening mobile duty in PS area vide Jhalda P.S. GDE No- 1352 Dated- 25/12/2023 in consonance with Jhalda PS CC No- 3908/23 Dated- 25/12/2023. During my Spl. evening mobile duty, at about 19:25 hrs, received a tip off that 01 (one) person is coming from Jharkhand side along Kansra more on Jhalda Gola road towards Jhalda by a Motor Cycle having bearing Reg. No. BR14H/8731 loaded with stolen steam coal. Subsequently, I informed to you and the duty officer and asked him to note down GDE vide No. 1360 dated 25/12/2023. Consequently, as per your kind order I started Naka at Kansra More by placing the guardrail on the Jhalda Gola road. Thereafter I saw 01 (one) person was coming towards Kansra more by a Motor Cycle with load. Consequently, we intercepted him along with 01 Motor Cycle having bearing Reg. No.- BR14H/8731 loaded with steam coal at Naka checking point at about 20:05 hrs. On being asked, he disclosed his identity as noted in the supra. I asked him to produce the valid documents in respect of the loaded steam Coal but he could not able to produce any kind of documents in respect of the loaded steam Coal. We waited for reasonable time but none came to spot to produce any documents in respect of the said steam Coal. So it is reasoned to belief that he procured the said steam coal from Jharkhand state by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo, I seized One Hero Splendor Plus Motorcycle having bearing Reg. No. BR14H/8731 & Chassis No. MBLHA10AMDHJ75072 loaded with approx 02 Quintal of steam coal after preparing proper seizure list in presence of available witnesses duly signed by them and also arrested the said accused namely Hakim Ansari (43) S/O Shoeb Ansari of vill- Jamsingh, PO-Ichahatu, PS-Rajrappa, Dist-Ramgarh, JKD after informing him the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said seized articles to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the accused person namely Hakim Ansari (43) S/O Shoeb Ansari of vill- Jamsingh, PO-Ichahatu, PS-Rajrappa, Dist-Ramgarh, JKD as he committed offence U/S- 379/411/413/414 of the IPC.
