

In producing herewith following seized articles; i) One Iron made single bore country made fire arms having length 27 cm (Approx) with butt, barrel, firing pin, trigger etc. (Length of barrel 15 cm approx and length of butt 14 cm approx) & ii) One round live ammunition, which was loaded inside Sl. No (i) which seized from the house of PC accused persons, as per their leading statement as well as identification & production at Vill-Kantadih, PS-Jhalda, Dist-Purulia.

I, SI Dipankar Biswas of O/C Kotshila PS do hereby lodge complaint that, today, (13.12.2023) at 20.05 hrs myself along with 02 PC accused persons i) Sk Afjal @ Batla (28 yrs) S/O-Sk Mansur of Vill-Kantadih, PS-Jhalda, Dist-Purulia ii) Sk Nur Tahir @ Majua (27 yrs) S/O-Sk Hanif of Vill-Kantadih, PS-Jhalda, Dist-Purulia and force held raid at Jhalda PS area, accompanied with Jhalda PS Police force in c/w the above noted case reference, as per leading to the confessional statement of the PC accused persons, [ held raid and searched into the house of PC accused Sk Afjal @ Batla at Kantadih village under Jhalda PS and recovered one stolen mobile phone from his house in c/w the above noted case but during search I was found One improvised country made fire arms loaded with One round live ammunition which was under the bed at his house, on interrogation the PC accused persons Sk Afjal @ Batla & Sk Nur Tahir @ Majua both confessed that it was collected by both of them to commit any crime and kept here, being asked they could not able to produce any valid document in respect of said fire arms & live ammunition, accordingly I seized the same under proper seizure list.

After that I turn up at Jhalda PS, myself produce the seized fire arms and live ammunition and as per direction of IC Jhalda PS myself submit this complaint as suomoto to start a specific case as per law.

Under above circumstances, I, therefore, pray that a case U/S 25(1)(a)/35 of Arms Act may kindly be initiated against PC accused i) Sk Afjal @ Batla (28 yrs) S/O-Sk Mansur of Vill-Kantadih, PS-Jhalda, Dist-Purulia ii) Sk Nur Tahir @ Majua (27 yrs) S/O-Sk Hanif of Vill-Kantadih, PS-Jhalda, Dist-Purulia, during search at Kantadih village, under Jhalda PS, Dist-Purulia.
